The 2024 Convention Budget was adopted at the previous BOD meeting with Debbie Hinchey, Convention Treasurer, being given the authority to sign checks on the PR Convention Account.

Carol Norquist presented a list of recommended fundraisers for the PR General Fund:

- 3. Order "I Love Garden Club" pins to sell to members.

There was no opposition to these recommendations.

# New Business/Information:

Carol Norquist shared concern regarding Idaho and Hawaii remaining in the Pacific Region. The 2025-2027 Director should be from Arizona. The 2025 Convention dates are pending. The 2026 Convention should be in Idaho. The 2025-2027 NGC Nominating Committee Delegates are from Oregon and Arizona.

Carol Norquist asked each of the state presidents to send her a copy of their 2023-2025 Board of Directors roster as well as their state Newsletters.

Carol Norquist announced that the next Executive Committee meeting will be held in Alaska in August 2024 (probably 8/21).
