New Business

Financial Report: Treasurer Susan Nash reported.

The proposal was sent to the Organization Study Committee to provide the language for the incoming 2023-2025 term. This will be presented for approval at the new term Executive Committee meeting.

Immediate Past Director Robin Pokorski reported for Financial Review Chairman Becky Hassebroek that all financial records for the 2021-2022 fiscal year were reviewed and were found to be in good order. She moved the adoption of the Reviewer's Statement. Motion passed. See attached.

1a. Rotation

Rotation among PRGC for the offices of Region Director and Alternate Region Director shall be as follows:

2. NOMINATING COMMITTEE

2b. Eligibility

NGC Bylaws shall be adhered to. NGC Bylaws Article X NOMINATING COMMITTEE, Section 1. - STRUCTURE, B. Members From *NGC Bylaws*, Revised Justified, May 2021 2022

- 1. To be eligible to serve as a Member, each member shall have served a minimum of two years as a member of the NGC Board of Directors and shall have attended two of the previous five NGC Conventions prior to assuming that position. The Member must reside within the Region represented.
- 2. The States from which the Members are selected shall be determined in rotation, as established by the NGC Standing Rules and must include each State Garden Club within the geographic areas designated in Article IV. If a State passes, the rotation continues forward in the rotation list.
- 3. The Member shall be elected by the Governing Board of the State Garden Club during

the even-numbered year prior to service.

4. If the Member is unable to attend a meeting, the State President shall appoint a member from the state and if no member is available the Region Director shall appoint a member from the Region already serving on the NGC Board of Directors to attend that meeting. The new member shall serve to the end of the term. No change in the rotation schedule.

The maximum number of delegates of any State Garden Club is twelve.

Each State Garden Club shall be entitled to the same number of elected alternates as elected delegates. An alternate shall become the delegate when a vacancy occurs.
