JIGPC PRIVACY STATEMENT

Jazan Integrated Gasification and Power Company (“**JIGPC**” or “us” or “we”) follows strict guidelines to protect personal data and ensure compliance with applicable data protection laws and regulations.

Your privacy is important to us and maintaining your trust is a priority.

1. Information We Collect

When you use the JIGPC website “jigpc.com” (“**Site**”), we may collect information about you (“**Personal Data**”), such as:

- Name
- Language
- Contact details (such as telephone numbers, email address, address)
- User login data
- Demographic data (e.g. date of birth)
- Technical Information (IP / Cookies)
- If applying for a job, employment history, nationality, date of birth, and other relevant information

We also may collect information about you from publicly and commercially available sources (as permitted by law), which we may combine with other information we collect when you visit our Site. This may include (but is not limited to) websites where you publicly include information about yourself such as Linked-in, Twitter, job sites or from other third-party sources. By using our Site, you are deemed to have given your consent for us to collect, process and use information about you from publicly and commercially available sources.

2. Collection, Processing and Use of Your Personal Data

By providing Personal Data through our Site, note that you are consenting to JIGPC collecting, processing and using the Personal Data for any legitimate purpose, including in relation to the following purposes:

- Registering to become a supplier;
- Applying for a job;
- Contacting us for partnership, supplier, or other business opportunities;
- Business execution including entering into of agreements with customers, suppliers and managing relationships with such parties;
- Communicating to our customers, investors, prospective and existing employees;
- Legal and/or regulatory compliance reasons; and

- Marketing, market analyses and statistical purposes.

3. How We Might Share Your Personal Data

By your use of our Site, you are also consenting to JIGPC sharing your Personal Data with third parties for any legitimate reason, as permitted by applicable law, including:

- Where we need assistance from third parties to grant you access to the Site and facilitate posting of information, content and/or otherwise operate the Site;
- Where we have a public interest or legal duty to do so;
- Where we have a duty to disclose to a competent public authority, government or regulatory agency where necessary to comply with a legal or regulatory compliance obligation which we are subject to or as permitted by applicable local law;
- Where required to our professional advisers or consultants, including lawyers, bankers, auditors, accountants and insurers providing consultancy, legal, banking, audit, accounting or insurance services to us;
- To enforce or apply any agreements we have with you; or
- To third party suppliers and vendors who we use to support our business, including but not limited to the operation, features and functionality of this Site, and those who provide information technology and system administration services to us.

4. Your Rights

You shall have the right, at any time, to:

- review your Personal Data which we have collected and to obtain a copy thereof in a clear format and at no charge (subject to any charges permitted in respect of credit information);
- have inaccurate Personal Data corrected or updated;
- object to the processing of your Personal Data; and
- have your Personal Data destroyed.

5. International Data Transfers

In case your Personal Data is to be transferred outside the Kingdom of Saudi Arabia (“**KSA**”), as permitted by applicable law, you will have the following rights:

- the right to be informed;
- the right to withdraw the consent to process the Personal Data outside KSA - at any time - unless the purpose of transferring the data is to achieve the public interest, protect the vital interests of individuals, or implement legal requirements by the government; and
- the right to access the Personal Data held with the third party, in order to review it, request correction, completion or update, request the destruction of what is no longer needed, and obtain a copy of it in a clear format.

6. Miscellaneous

By sharing with us your Personal Data through the Site, you acknowledge that such shared Personal Data is the minimum personal data necessary for the contemplated purposes for which JIGPC will be collecting and processing the Personal Data.

JIGPC will only retain the Personal Data for as long as is necessary to fulfill the purposes for which the Personal Data was collected. Once the Personal Data is no longer required, then it will be destroyed.

We assume that the Personal Data which you share with us is accurate and complete at all times. As such you must ensure that the Personal Data is accurate and complete at the time of the initial sharing, and that the Personal Data is updated as necessary so that it remains accurate and complete at all times.
