The 2019 Sumter County Fair dates are March 1 - March 9, 2019. We are looking forward to the fair being bigger and better than ever.

The Commercial Building will be open Tues February 26 through Thursday, February 28 from 9:00 a.m. until 4 p.m. for the decoration of your booth. You may **NOT** use staples and/or tacks on your displays. However, no nails, painting, or permanent structures allowed. No attachments to the walls. Displays should not extend above the dividers. This will prevent obstruction of the view from one end of the building to the other. Booth set-up must be completed by eleven am Friday March 1.

Eighteen (18) 1-day fair tickets will be issued per commercial exhibit. These tickets are for commercial exhibit workers and are for a one-time entrance only. These tickets will be collected at the gate upon arrival at the fair. Additional tickets may be purchased for \$2.00 per ticket. Weeklong fair passes may be purchased for \$20.00. Note: No passes/tickets will be left at the ticket window. Exhibitors will be responsible for giving passes/tickets to workers. No exceptions!

No space will be reserved without execution of the commercial merchandise display agreement. To be assured of a space, complete and return application and agreement by February 22, 2019. NO BOOTH SHALL BE BROKEN DOWN BEFORE 9:00 PM CLOSING NIGHT.

That for and in consideration of the mutual promises undertakings herein contained, the parties as follows:

1. SFA does hereby grant to me Commercial/Merchandise Display Agreement at the 2019 Sumter County Fair. I shall use said space to display: _____
2. I hereby agree to pay SFA the sum of \$100.00 for the display space, with the execution of this agreement. **No backwall space is included with this rental.**
3. Back wall space will be available on a first come basis and the rental rate is \$150.00
4. This agreement shall not be transferred, sold, assigned, or sublet in whole or in part, or recorded, without written consent of SFA.
5. I shall make no unlawful, improper, or offensive use of the above area, and shall vacate and deliver said area at the end of the above-mentioned Sumter County Fair in as good condition as it is now.
6. In the event I default, I shall be liable for all costs and expenses, including a reasonable attorney's fee, incurred by SFA in enforcing its rights hereunder.
7. I shall be responsible for my own insurance, including but not limited to theft, fire, windstorm, and liability. I shall hold SFA harmless from any responsibility of liability if damages are incurred by me during the term of this agreement.
8. Nothing can be put all walls we remove anything attach to them and you will no longer be able to obtain a space from us.
