2020 SUMTER FAIR ASSOCIATION YOUTH BEEF PRODUCTION SHOW RULES AND REGULATIONS

PURPOSE:

THE INTENT AND PURPOSE OF THE SUMTER FAIR ASSOCIATION YOUTH BEEF PRODUCTION SHOW IS TO PROVIDE A MEANS TO PROMOTE THE ANIMAL INDUSTRY IN FLORIDA. FURTHERMORE, THIS IS AN EDUCATIONAL PROJECT FOR YOUTH IN FLORIDA AND SHOWING PROVIDES YOUTH WITH A MEANS TO GAIN RECOGNITION FOR ACHIEVEMENTS IN THE BEEF PROJECT.

ELIGIBILITY:

1. ONLY A BONA-FIDE 4-H OR FFA MEMBER, WHO IS AT LEAST 8 YEARS OF AGE AS OF SEPTEMBER 1ST AND IS ENROLLED IN A FLORIDA RECOGNIZED SCHOOL. YOUTH MUST NOT HAVE COMPLETED THE 12TH GRADE.
2. THE SHOW SHALL BE OPEN TO REGISTERED OR CROSSBRED BEEF BREEDING ANIMALS.
3. EACH EXHIBITOR/OWNER MUST ASSUME ALL LIABILITY IN CASE OF DEATH OR INJURY TO HIS/HER ANIMAL AND ANY INJURY OR DEATH INCURRED BY HIS/HER ANIMAL. THE SUMTER FAIR ASSOCIATION AND/OR DIRECTORS WILL NOT BE HELD RESPONSIBLE OR LIABLE FOR ANY INJURY OR LOSS TO HUMAN, ANIMAL OR PERSONAL PROPERTY.

ENTRIES:

1. THERE WILL BE NO MAXIMUM NUMBER OF ENTIRES PER EXHIBITOR.
2. **THE FEE FOR OUT OF COUNTY EXHIBITOR IS \$30.00 ENTRY FEE FOR FIRST ANIMAL AND \$20.00 THEREAFTER PER ADDITIONAL ANIMAL PER EXHIBITOR. THERE IS A \$10.00 FEE FOR SHOWMANSHIP. CHECKS NEED TO BE PAYABLE TO THE SUMTER FAIR ASSOCIATION.**
3. **THE FEE FOR IN-COUNTY EXHIBITOR IS \$25.00 ENTRY FEE FOR THE FIRST ANIMAL AND \$15.00 THEREAFTER PER ADDITIONAL ANIMAL PER EXHIBITOR. THERE IS A \$10.00 FEE FOR SHOWMANSHIP. CHECKS NEED TO BE PAYBLE TO THE SUMTER FAIR ASSOCIATION.**
4. USE A SEPARATE ENTRY FORM FOR EACH EXHIBITOR
5. ALL INFORMATION AND SIGNATURES MUST BE COMPLETED ON ENTRY FORM.
6. ENTRIES MUST BE ON OFFICIAL ENTRY FORM AND MUST BE RECEIVED BY **FEBRUARY 28, 2020** ALONG WITH ENTRY FEE.
7. ENTRIES WILL BE ACCEPTED AT CHECK-IN. HOWEVER, A \$15.00 LATE FEE WILL BE APPLIED TO THE APPLICATION.
8. **CASH ONLY ENTRY FEES ACCEPTED THE DAY OF SHOW.**
9. EACH ANIMAL MAY BE SHOWN IN A SINGLE CLASS.
10. ANIMALS MUST BE SHOWN IN THEIR RESPECTIVE DIVISION AND AGE CLASSES. EXHIBITS THAT HAVE BEEN INCORRECTLY ENTERED MAY, AT THE DISCRETION OF THE SHOW COMMITTEE, BE TRANSFERRED TO THEIR PROPER DIVISION/CLASSES PRIOR TO JUDGING.

HEALTH REGULATIONS:

1. ALL ANIMALS MUST MEET HEALTH REGULATIONS AS SPECIFIED IN THE RULES FOR EXBIHITION AS REQUIRED BY THE FLORIDA DEPARTMENT OF AGRICULTURE & CONSUMER SERVICES.
2. ALL ANIMALS MUST BE ACCOMPANIED BY AN OFFICIAL HEALTH CERTIFICATE AND PERMANENT ID.
3. NO VET CHECK AT THE SHOW.
4. ALL ANIMALS MUST BE EITHER DEHORND OR POLLED
5. NO ANIMAL OLDER THAN 36 MONTHS.

GENERAL:

1. THE OWNER IS RESPONSIBLE FOR THE CARE AND CLEAN-UP OF HIS/HER OWN ANIMALS. ALL EXHIBITORS ARE REQUIRED TO HAVE THEIR STALL AREAS CLEAN BEFORE LEAVING THE GROUNDS. IN ORDER TO RECEIVE PREMIUM MONEY, THE STALLS MUST BE CHECKED OUT BY THE BARN SUPERINTENDENT.
2. DUE TO THE EXCESSIVE DEMAND ON THE ELECTRICAL OUTLETS, GENERATORS ARE WELCOMED.
3. EXHIBITORS WILL BE RESPONSIBLE FOR THE SAFETY OF THEIR ANIMAL UPON ENTERING THE FAIRGROUNDS.

4. THE SPACE FOR GROOMING CHUTES WILL BE VERY LIMITED. GROOMING CHUTES MUST BE CONFINED TO THE AREA DESIGNATED.
5. ALL EXHIBITORS MUST DOUBLE TIE THEIR ANIMALS WITH A NECK ROPE.
6. THE EXHIBITOR MUST SHOW THEIR OWN ANIMAL IN SHOWMANSHIP.
7. EXHIBITOR IS REQUIRED TO WEAR BLACK PANTS, WHITE SHIRTS, CLOSED TOED DARK SHOES OR BOOTS, ACCOMPANIED BY OFFICIAL TIE, JACKET/VEST EITHER 4-H OR FFA. NO ENTRY INTO THE SHOW WITHOUT OFFICIAL DRESS.
8. ONLY ONE ENTRY ARMBAND FOR EXHIBITOR. PARENTS OR GUARDIANS WILL NOT RECEIVE A PASS. PASSES CAN BE PURCHASED AT THE GATE AT TIME OF CHECK-IN.
9. SHAVING FOR THE STALLS ARE NOT PROVIDED. EXHIBITOR MUST BRING THERE OWN.

ETHICAL TREATMENT:

ALL ANIMALS MUST BE TREATED IN AN ETHICAL AND HUMANE MANNER. ALL ANIMALS MUST BE SHOWN IN THEIR NATURAL CONFORMATION AND THE STRUCTURE WITHOUT ALTERCATION BY MODIFICATION EXCEPT FOR THE GROOMING AND TREATMENT OF THE HAIR AND TRIMMING OF THE HOOVES. ANY VIOLATION MAY RESULT IN THE DISQUALIFICATION OF THE ANIMAL AND THE EXHIBITOR.

SHOWMANSHIP: AGE AS OF SEPTEMBER 1, 2019

1. ALL EXHIBITORS MUST SHOW THEIR OWN ANIMAL.
2. ALL SHOWMANSHIP ANIMALS MUST BE ENTERED IN A JUDGED CLASS.
3. NO BULLS ALLOWED IN SHOWMANSHIP
4. JUNIOR 8 YEARS OLD – 10 YEARS OLD
5. INTERMEDIATE 11 YEARS OLD – 13 YEARS OLD
6. SENIOR 14 YEARS OLD – 18 YEARS OLD

SCHEDULE:

1. CHECK-IN IS FROM 6:00AM UNTIL 9:00AM
2. THE SHOW WILL BEGIN AT 11:00AM ON SATURDAY MARCH 7, 2020 AT THE SUMTER COUNTY FAIRGROUNDS.
3. AFTER STALL AREAS ARE CLEAN, ANY PREMIUMS EARNED WILL BE AWARDED AND ANIMALS RELEASED.

JUDGING:

THERE WILL BE NO DIVISIONS FOR ANIMAL BREEDS- ALL BREEDS WILL SHOW TOGETHER. ANIMALS WILL BE JUDGED USING THE DANISH SYSTEM. ANY ANIMAL WITH A CALF AT HER SIDE WILL BE SHOWN IN A COW CLASS. THE JUDGE'S DECISION IS FINAL.

CLASSES:

ALL HEIFERS WILL BE WEIGHED AND SHOWN ACCORDING TO WEIGHT. CATTLE CAN BE WEIGHED BETWEEN THE HOURS OF 6:00AM AND 9:00AM. THE HEIFERS WILL BE DIVIDED INTO SIX CLASSES ACCORDING TO THEIR WEIGHT.

BULLS WILL BE CLASSIFIED BY THEIR WEIGHT. NO BULLS WILL BE ALLOWED IN SHOWMANSHIP. BULLS WEIGHING 800LBS. AND OVER MUST HAVE A BULL RING.

THE COW/CALF CLASSES WILL BE WEIGHED WITH CALF BY ITS SIDE.

EVERY REASONABLE ATTEMPT WILL BE MADE TO PROVIDE A SAFE ENVIRONMENT FOR ANIMALS AND EXHIBITORS. THE SUMTER FAIR ASSOCIATION BOARD OF DIRECTORS, VOLUNTEERS, AND STAFF WILL NOT BE RESPONSIBLE FOR ANY ACCIDENTS OR INJURIES THAT OCCUR WHILE IN TRANSIT OR WHILE AT THE FAIR OR ANY VENUE BEING USED BY THE FAIR ASSOCIATION FOR A FAIR EVENT. EXHIBITORS OR GUARDIANS AGREE TO HOLD AND INDEMNIFY SUMTER FAIR ASSOCIATION AND IT REPRESENTATIVES, AND VOLUNTEERS HARMLESS FROM ANY AND ALL LIABILITY ARISING OUT OF EXHIBITOR'S USE OF FACILITIES, INCLUDING INJURY OR DAMAGE TO EXHIBITOR/ OR ANIMAL OR ANY PARTICIPANT AND PUBLIC. THE SUMTER FAIR ASSOCIATION WILL NOT BE RESPONSIBLE FOR ANY LOST OR DAMAGED PERSONAL ITEMS.
