5. In the event of default by "Vendor", "Vendor" shall be liable for all cost and expenses, including a reasonable attorney's fee, incurred by "SFA" in enforcing its rights hereunder.
6. "Vendor" shall be responsible for his/her own insurance, including but not limited to theft, fire, wind storm and liability, and shall hold the "SFA" harmless from responsibility of liability if damages incurred by "Vendor" during term of this agreement.
