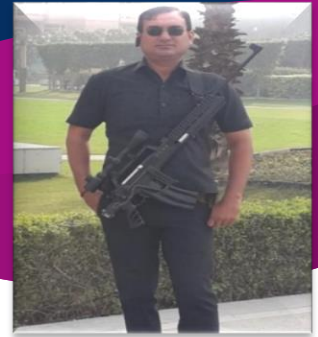




OUR SERVICES

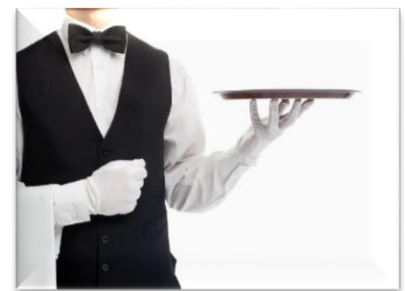
