MEMBERSHIP AGREEMENT

Membership Agreement between EK's Art Barn and the Member, for shelf space and use of facilities at the listed address.

Term: Member agrees to Membership for a term of their choosing, based on Table 1, for a minimum of 3 months. Discounts are offered for auto-paid Memberships. If a Member terminates their Membership, they agree to give EK's Art Barn one month's notice before the Membership expires. All Members will be considered auto-renewing unless notified with sufficient notice. Members that wish to pause their memberships and return after a pause will be subject to a signing fee. Signing fees are waived for all first-time Members.

Membership: Members are entitled to the following privileges:

- 24/7 access to the EK's Art Barn (with 48-hour notice of arrival)
- 1 FREE bag of clay upon initiation of first-time Membership status
- Designated shelf space for storage of personal tools, materials, equipment, and work
- Bisque and glaze firing, within the scope of the kiln's capacity (Ask the Owner or Manager for specifics)
- Designated studio glazes
- Member rates for classes and workshops, and use of Open Studio during classes and workshops for personal projects (as space allows)
- Friends and family quests for a discounted drop-in rate, by appointment
- Opportunity to purchase materials at bulk pricing
- Invitation to sell wares in Events and Shows hosted by EK's Art Barn throughout the year

Payment: Members will make monthly Membership payments according to Table 1 to EK's Art Barn on the first of each month. Refer to Table 1 for bundle rates and payment options. Member will review and sign the Acknowledgments and Expectations of both the Member and EK's Art Barn. Payment must be paid to EK's Art Barn by the 5th of the month, or a late fee of \$10 / week will be charged to the Member, in addition to their monthly dues. If the Member becomes 1 month delinquent in Membership dues, their Membership status may be revoked until payment is issued. If the Member is delinquent for over a month and does not return to vacate the shelf, EK's Art Barn staff reserves the right to box Member's work, tools, and supplies and leave in the silo for pick up. Items abandoned in the silo for 3+ months will be donated. Memberships can

begin at the start of the month, or on the 15th for a prorated amount until the 1st of the following month.

Confidentiality: EK's Art Barn will keep credit card information confidential and will be deleted when the Membership has ended. If the Member pays by recurring payment, it is the Member's responsibility to stop automatic payments if they are no longer a Member.

Membership Termination: A Member may terminate their Membership by giving a month's notice to the staff of EK's Art Barn. If the Member vacates their shelf, all past-due payments owed to the studio are still required. Memberships are non-refundable, unless agreed upon by the staff of EK's Art Barn. The EK's Art Barn staff reserves the right to end the Membership Agreement as described in the EK's Art Barn Acknowledgements and Studio Expectations. The Member is responsible for:

- Following the safety procedures and studio rules which are posted at the studio
- Maintaining a reasonably clean shelf (wiping with a wet sponge regularly to reduce dust build-up)
- Seeking assistance before using unfamiliar equipment
- Cleaning workspace, tools, and equipment after use, before departure
- During scheduled class times, Members will use designated space not in use by the class.
- Adhering to the responsibilities associated with working in a 24/7 facility. Additionally, non-members are not to be invited without prior approval by EK's Art Barn staff to ensure safety and security
- Using equipment only for their intended (or artistic) uses
- Members acknowledge that EK's Art Barn may use their image and pictures of their work on social media and other forms in order to promote the studio. Members may give notice to the EK's Art Barn staff if they do not want their images to be posted.

Discounts	Senior discounts are offered to Members ages 65+ for a monthly rate of \$125 / month. Children (under the age of 16) can be added onto a single adult membership for \$30 / child. Non-Member guests are welcome to drop-in with a Member patron for just \$25. KSU Student discounts are offered to Student Members for a monthly rate of \$125 / month.
