

Liability Release: Under Kentucky law, KRS 247.401 to 247.4029 a farm animal activity sponsor, farm animal professional, or other person does not have the duty to eliminate all risks of injury of participation in farm animal activities. There are inherent risks of injury that you voluntarily accept if you participate in farm animal activities.

No participant or participant's representatives shall make a claim against, maintain and action against, or recover from an equine activity sponsor or any other person for injury, loss, damage or death of the participant resulting from the inherent risk of equine activities. I (we) release the Rocky Mountain Horse Association as well as it's members and volunteers of any an all liability which may arise as a result of injury to my (our) person or property that may be sustained in connection with an equestrian related activity.

Rider Responsibility: I understand that, notwithstanding the presence or participation of an instructor or training, upon mountain a horse and taking up the reins, the RIDER is in primary control of the horse. The rider's safety depends largely upon his or her ability to carry out simple instructions, and his or her ability to remain balanced aboard the moving animal. The RIDER shall be responsible for his or her own safety and that of an unborn child if the rider is pregnant.

PROTECTIVE HEADGEAR/ EQUIPMENT WARNING: I agree that for myself and on behalf of my child and/or legal ward have been fully warned and advised by Releasees that protective headgear and equipment should be worn while riding and being near horses and I do understand that the wearing of such equipment at these times may reduce the severity of some of the wearer's head injuries and possibly prevent the wearer's death from happening as the result of a fall and other occurrences.

Horses can be unpredictable in their reactions to a variety of stimulus both natural and man-made. I understand that there are inherent risks of equine related activities which could result in injury or death.
