PRIVATE EVENTS TERMS AND CONDITIONS



NOISE RESTRICTIONS

In accordance with Planning Consent, Fleurieu Gin is required to adhere to a strict Noise Management Plan to ensure the amenity of the locality is not unreasonably impacted. Maximum noise limits apply and all music shall cease no later than 11:30pm. A soloist or an unamplified acoustic duo playing outside must cease no later than 8pm.

CONFIRMATION OF FOOD & GUEST NUMBERS

Confirmation of food, guest numbers and beverages options are required no later than 7 days prior to your event date.

CANCELLATION

Deposits are fully refundable if the cancellation is made at least 7 days prior to the event. Cancellations made within 7 days of the scheduled event will result in the forfeiture of the deposit. All cancellations must be submitted in writing.

VENUE LICENSE REQUIREMENTS

Fleurieu Gin has a 200-person capacity and will cease the serving of alcohol by 11.30pm with all guest to be off site by 12 midnight.

The staff at Fleurieu Gin practice the safe responsibility of service of alcohol and have a right to refuse service to anyone that is intoxicated or disorderly. These guests will be asked to leave the premises immediately. We will not supply alcohol to persons under the age of 18 years of age. Strictly, NO alcohol is permitted to be brought onto the premises and consumed unless prior arrangement has been made.

CHILDREN

Children often make the event memorable and are very welcome at Fleurieu Gin however due to the nature of the rural environment and with livestock nearby, children are to be supervised at all times.

GUEST BEHAVIOUR

Abusive, aggressive, or violent behaviour towards other guests or staff will not be tolerated. Fleurieu Gin reserves the right to ask any guests involved in this behaviour or any illegal activity witnessed to immediately leave the premises.

DAMAGE, LOSS OR THEFT

The client is held responsible for any damages made to Fleurieu Gin by the client or guests, caused accidentally or otherwise. It is the client's responsibility of any hired equipment or decorations brought onto the premises and must be removed by 9:30am the following day. Failure to do so will result in charges for staff time and any necessary storage.

CLEANING

General cleaning is included in the venue hire fee. However, if the condition of the venue following the event requires cleaning beyond what is considered reasonable, additional cleaning charges will apply. An additional fee will be incurred should the movement or storage of venue furniture be required.

CLIENT RESPONSIBILITY
