All wines are subject to availability and may change from time to time. Substituted wine will be of similar or higher quality.

Packages are served for 5 hours from 6pm to 11pm.

# OUR RULES/TERMS AND CONDITIONS

## PAYMENT SCHEDULE AND BOOKING FEE

A \$2,000 booking fee is to be paid to secure your selected date. These funds will be held as a security bond. Should any losses, breakages or damages occur by you or your guests to Fleurieu Gin, the costs will be deducted from the bond. The security bond will be refunded back to you within 5 business days after your event (subject to no damages)

Venue hire amount is to be paid 60 days prior to the event date. The full amount of the Food and Beverage package is to be paid 30 days prior to your event. Any extra expenses incurred on the night will need to be settled within 2 days of your event.

## PAYMENT OPTIONS

EFT is preferred.

## CONFIRMATION OF GUEST NUMBERS

Confirmation of guest numbers and beverages options is required no later than 30 days prior to your wedding date. The number of guests confirmed at that time will be the minimum number you will be charged for and no refunds will be given if this number decreases.

## CANCELLATION

In the event of a cancellation, the booking fee is non-refundable unless approved by Fleurieu Gin. If the event is cancelled with less than 30 day's notice, 50% of the paid hire fee will be forfeited. Within 7 days of the event, the full venue hire fee will be forfeited. All cancellations need to be in writing.

## VENUE LICENSE REQUIREMENTS

Fleurieu Gin has a 200-person capacity and will cease the serving of alcohol by 11.30pm with all guest to be off site by 12 midnight. Access to grounds from 4pm (ceremony) or 5pm (reception only) due to our lunch time service. Transport will need to be pre organised due to the location of Fleurieu Gin.

The staff at Fleurieu Gin practice the safe responsibility of service of alcohol and have a right to refuse service to anyone that is intoxicated or disorderly. These guests will be asked to leave the premises immediately. We will not supply alcohol to persons under the age of 18 years of age.

Strictly, NO alcohol is permitted to be brought onto the premises and consumed unless prior arrangement has been made.



## CHILDREN

Children often make the day memorable and are very welcome at Fleurieu Gin however due to the nature of the rural environment and with livestock nearby, children are to be supervised at all times.

## GUEST BEHAVIOUR

Abusive, aggressive, or violent behaviour towards other guests or staff will not be tolerated. Fleurieu Gin reserves the right to ask any guests involved in this behaviour or any illegal activity witnessed to immediately leave the premises.

## DAMAGE, LOSS OR THEFT

The client is held responsible for any damages made to Fleurieu Gin by the client or guests, caused accidentally or otherwise. Fleurieu Gin does not accept responsibility for damage or loss of gifts or goods before, during or after the event. Any small personal items left behind will be disposed of after 30 days.

It is the client's responsibility of all hired equipment or goods brought onto the premises. Fleurieu Gin is not liable for any introduced food consumed including allergies.

## CLEANING

General cleaning is included in the venue hire fee. However, if the condition of the venue following the event requires cleaning beyond what is considered reasonable, additional cleaning charges will apply. The use of confetti, rice, or similar materials is not permitted. Fresh rose petals are welcome.

An additional fee will be incurred should the movement or storage of venue furniture be required.

All client or hired property and décor must be removed from the venue by 10:30am the following morning. Failure to do so will result in charges for staff time and any necessary storage.

## ENTERTAINMENT

In accordance with Planning Consent, Fleurieu Gin is required to adhere to a strict Noise Management Plan to ensure the amenity of the locality is not unreasonably impacted. Maximum noise limits apply and all music shall cease no later than 11:30pm. A soloist or an unamplified acoustic duo playing outside must cease no later than 8pm.

A full copy of the Noise Management Plan is required to be provided to all booking parties.

## CLIENT RESPONSIBILITY

It is the responsibility of the client to adhere by the terms and conditions. Fleurieu Gin shall not be liable for any loss, injury, theft, or damage to any goods brought to the venue. Please inform all relevant parties of our venue's terms and conditions. The client is also responsible for the set up and pack down of all hired goods. Vehicles are not to be driven or parked on the irrigated lawn areas.

Please read the terms and conditions carefully and ask for clarification if you have any questions or concerns. By signing the terms, they are binding. Please keep a copy for your records.
