

NOTICE TO BIDDERS

Sealed proposals for the furnishing of all labor, materials, and equipment necessary for the development and installation of:

WATER SUPPLY PLANT #2

The City of Carls Corner

Hill County, Texas

to include a new ground water storage tank, yard piping, and fencing, together with all other appurtenant construction for a complete and functional system will be received at the offices of *Wasteline Engineering, Inc., 5064 East Interstate 20 Service Road South, Willow Park, Texas 76087*, until **11:00 a.m., local time, April 23, 2026**, and then publicly opened and read aloud.

The project to be constructed will be financed with assistance from the Texas Department of Agriculture (TDA) under U.S. Department of Housing and Urban Development Community Development Block Grant (CDBG) program and is subject to all applicable Federal and State laws and regulations. This project has been designated as **TxCDBG Contract #CDV23-0466**.

Attention is called to the fact that not less than the federally determined prevailing (Davis-Bacon and Related Acts) wage rate as issued by the Texas Department of Agriculture and contained in the contract documents must be paid on this project. In addition, the successful bidder must ensure that employees and applicants for employment are not discriminated against because of race, color, religion, sex, sexual identity, gender identity, or national origin.

Adherence to the grant recipient's Section 3 Policy is required for contracts and subcontracts.

Iron and steel products, Manufactured Products, and Construction Materials used in the project shall comply with the Build America, Buy America Act (BABA) requirements mandated by Title IX of the Infrastructure Investment and Jobs Act ("IIJA"), Pub. L. 177-58.

All contractors/subcontractors that are debarred, suspended, or otherwise excluded from or ineligible for participation in federal assistance programs may not undertake any activity in part or in full under this project.

A subscription to CivcastUSA is required to submit an electronic bid. By submitting an electronic bid, the Bidder agrees and represents that it has the authority to submit such bid and that such bid constitutes a valid bid submitted in accordance with the Contract Documents without further signature or action by the Bidder. All electronic bids are deemed to incorporate the provisions of the Contract Documents. Electronic bids must be submitted via CivcastUSA before the closing time indicated on this Notice to Bidders. Bid bonds shall be submitted electronically through the facilities of CivcastUSA in satisfaction of the Bid Security requirements described herein; however, certified or cashier's checks in satisfaction of the Bid Security requirements must be enclosed in a sealed envelope, plainly identified on the outside with the contents, the bidder's name, and the job name and addressed and delivered to Wasteline Engineering, Inc., 5064 E I-20 Service Road South, Willow Park, Texas 76087 at or prior to the time and date above.

Bids will not be accepted by email.

Plans, specifications, and contract documents may be examined without charge at the offices of *Wasteline Engineering, Inc.* Digital versions of the sealed plans and specifications, with Bid Forms, are available at www.civcastusa.com at no charge. Interested parties must register for a free account to access and be informed of any future bid phase documents and/or changes.

The Owner reserves the right to reject any or all bids and waive any or all defects and irregularities in the bidding. Bids may be held by the Owner for a period not to exceed sixty (60) days from the date of the bid opening for the purpose of reviewing the bids and investigating the bidder's qualifications prior to the contract award. The Successful Bidder, if any, will be the responsible bidder which in the Owner's judgment will be most advantageous to the Owner and result in the best and most economical completion of the Project.
