Minutes for the November 17, 2018 ABSC Membership Meeting at Ribeye’s at Cape Carteret.

President Jesse Bradshaw called the meeting to order at 7:35 PM. Attending were Board Members Joe Honeycutt, Chair for fund-raising; P.J. Barbour; Treasurer, Anna Bradshaw, Chair for communications/membership; Bob Upchurch, Chair for fund-raising. In attendance were 35 members and 11 guests for a total of 46.

President Jesse welcomed the membership to our Thanksgiving social and thanked Mr. Henry Gurganus for allowing us to meet at Ribeye’s.

President Jesse ask the new board members to stand as he introduced them to the membership, and thanked them for already being an asset to the club.

President Jesse asked Joe Honeycutt, in the absence of Secretary Addie Lou Briley, to read the minutes of the last membership meeting held on July 28, 2018. The minutes were corrected by P.J. Barbour, Treasurer, with a balance of funds at that time of \$10,760.71. Motion to approve and seconded from the floor, and unanimously approved by the membership.

President Jesse asked Treasurer P.J. Barbour to give the treasurer's report. Current balance is \$16,789.70 with \$200 in petty cash. The 2018 2019 IRS tax form was filed by Curtis Smith (Auditor for ABSC) on October 22, 2018 for tax exempt and non-profit status. Motioned by Austin Waters and seconded by Ed Womble and approved unanimously by the membership.

President Jesse announced the cancellation of the December 1st Christmas Party. He also explained that the investors notified him Thursday that the club repairs are unfinished. Austin Waters and Danny Navey spoke on their regret of postponing the opening date to late December or early January 2019.

Joe Honeycutt reported on the CSA contest scheduled for Jan. 11th and 12th at Memories Beach Club. Sponsorship monies total \$6,150 with all sponsors having paid.

Membership/Communications Chair Anna Bradshaw gave a report. There are currently 142 members. Newsletters are going out monthly and containing the decisions made by the board as well as other pertinent information. Visiting the website and reading the newsletter are encouraged. Name badges are to be ordered in December; contact Anna if your name on your membership form is incorrect. Membership cards were given out to all members present.

New business by President Jesse included a recommendation for a \$500 donation, already approved by the ABSC board, to Memories Beach Club investors. The club investors present were asked to step out while a vote was taken. Prior to voting, Joe Honeycutt, the President, and Anna Bradshaw spoke on the importance of supporting “our” club by this donation. Motion to approve by Hazel Moseley, seconded by Annette Maready and Lyn Honeycutt, membership voted by a show of hands and approved by a majority of the membership. Also recommended was a donation of \$100 to the dance team for their travels to the U.S. Open in California. This having already been passed by the board. During a motion to approve, a recommendation was made by Hazel Moseley to increase the amount to \$200. A motion to approve the \$200 donation was raised by Hazel Moseley and seconded by P.J. Barbour. Unanimously approved by the membership.

President Jesse announced that Bob Upchurch had suggested a float or car presence representing the ABSC in the Newport Christmas parade on December 2nd. President Jesse and Bob Upchurch stated that there had been no interest, therefore it was decided to table the idea and wait until 2019.

President Jesse asked all the membership to give to Toys for Tots as several members brought up the continued support to the children at Christmas. Two bikes will be purchased by the ABSC and given to the Toys for Tots at the Ribeye’s location.

President Jesse thanked all for attending and wished everyone a Happy Thanksgiving; and a Happy Birthday to Sara Cozart.

A motion to adjourn was taken and approved by membership.
