To begin... a quote from me, Aswad Syed.

"There is no greater expression of hatred and hostility toward prisoners than to try and erase our existence as a category of people and to minimize us to the point of being viewed as non-human."

I am prisoner at Santa Rita Jail ("SRJ"), and I am a Black man. When I see people who look like me being abused or murdered by law enforcement, it hurts me. I am not one of those Jeffin-House Negros like U.S. Supreme Court Justice Clarence Thomas. I am not going to sit down and be quiet and play nice. I am like Antioch, California's Mayor, Lamar Thorpe. I am going to speak up on mine and to hell with what anyone thinks. This quote I began with is directed toward every law enforcement and government official who thought we would remain invisible to the public at large. I'm not going to talk y'all to death. You have seen the photos we have posted, and I encourage you to take time out of your day to say their names. Purpose it in your heart today but take a stand against the forces of fascism and racism in America.

Ask yourself this question:

"How can I help amplify the voices of the underserved and underprivileged communities of color?"

Sisters and brothers, America is in crisis today. We have a gun violence crisis, a substance abuse crisis, a mental health crisis, and a police violence crisis. Now, if we come together in love and community with one another, I believe we can begin to come up with realistic solutions to these crises. I need y'all to feel me on this. I am far from perfect. I've made some mistakes; I've caused harm, but I am ready to take the next step toward restoration and change. I'm sincere about this. Are you? What are you willing to stand up

against? What motivates you to act in the interest of a human being?

I'm going to tell you exactly what I stand against. I stand against those who plot to harm or murder the innocent. I stand against those who hate Jewish or Asian people. I stand against those who ridicule, torture, and target our LGBTQ sisters and brothers. I stand against those who pollute our planet. I stand against every White Supremacist and White Nationalist in the world. I vow to stand against myself when I act, behave, or speak in a contrary manner to my core beliefs.

Stand up today!

The following are highlights of some of many children who have lost their lives at the hands of others in America recently and over the last few years. We want to make sure the families of these individuals know that we support them.

We are truly saddened and disturbed by these acts of violence. NO ONE should take the life of another. The perpetrators of these senseless acts need to be held accountable for their actions, no matter who they are. A person should never be able to hide behind a badge, black robe, or local, state, or federal agency position. The law is the law.
