- C. Streets/Village Administrator: Nate Light reported that the sidewalk has been formed in front of village hall. A quote was obtained from Superior Foundation to pour this concrete as the village does not have equipment to do this in the amount of \$1200.00. Miller moved Rivera 2<sup>nd</sup> to approve this quote, all yes motion carried. A few weeks after the sidewalks are completed that state will paint the crosswalks there.
- **D. Zoning Inspector**: Melissa Vogelsong gave update and asked what the notice time is to allow residents in violations of village zoning, Mr. Skaff stated the ORC states 5 days, however the village allows up to 7. Ms. Vogelsong wanted to make sure she is doing her job correctly. The fiscal officer has stated at least 30 days, Mr. Skaff looked at the statue and it states 5 days. The fiscal officer will get clarification from the Henry County as to time frame and what is needed to asses property taxes if necessary for work the village has to do.
