Village Residents and Neighbors of the property located at 615 South East Street approached council concerning animals, children and trash at this property. Mr. Light stated that he had called the sheriff on a barking dog, there was discussion on if this is the sheriff's job to respond. The village does not have any ordinance's against having roosters however they cannot be running loose, they need to be contained. It was asked about having no engine breaks signs placed, these are in place however it is hard to enforce this issue. Council would like the sheriff to attend a council meeting. Another neighbor stated that she is very tired of all this noise and animals, she counted 20 ducks, 40 chickens, 2 turkeys, 9 dogs with one dog having puppies. Also stated is the children are not in school, though not sure of all the children's ages. The zoning inspector can call CPS. Ms. Vogelsong also stated that her dog was killed there a few years ago as she came to council and was told council cannot do anything about is. It was stated that someone had died of an overdose at this property. A visitor in the audience asked who they can call for a wellness check for the children without getting in trouble. Mayor Nagy stated now that council is aware

council will look into this. Councilperson Andrew Borck stated he does not hear the dogs or chickens from the said address however he does hear someone else's birds most of the time. George Miller told of an incident when his grandson was younger and was bitten by a dog, this dog had to be quarantined with the health department being involved. It was stated that someone was walking their dog and was recently attached by another dog, Mr. Light will contact sheriff as well to attend a council meeting.
