**9. Old Business:**

**A.** Paul Skaff reported that he has an email from ODOT asking where council stands on the options that were presented for ST 6 and 65. Questions were asked about the raised sidewalk and if something were to happen who would be responsible. Mr. Skaff reported that he visited a City where they had raised sidewalks and they have had no issues. Snow Plows would have to raise their blades. Council was reminded that the village would be responsible for 10 percent on any project they decide on. The raised sidewalk and the lighted crosswalk would cost approximately \$200,000.00. The ODOT representative stated that he was not aware of a grant being awarded for both the raised crosswalk and lighted crosswalk. **Gray moved Nagy 2<sup>nd</sup> to move forward with the raised crosswalk and lighted crosswalk with ODOT**, George Miller asked if they don't combine both can the village adjust the motion to one project, **majority yes with Borck voting NO, motions stands adopted.**

**10. New Business:**

- A. R-2023-6 Certification for replacing existing tax levy**, Gray moved to suspend the rules Miller 2<sup>nd</sup> to pass as an emergency with Gray moving Miller 2<sup>nd</sup> for the 1<sup>st</sup> reading. All yes on both motions, resolution stands adopted.
- B.** George Miller presented a quote from National Paving Analyst that will assess the streets and present a street program for a 3-year cycle. Mr. Miller and Andrew Borck feel this is a good example. Nate Light reported that the Village of Deshler utilized this program and it is very helpful. Brock moved Gray 2<sup>nd</sup> to accept this quote in the amount of \$3,000.00, all yes with Ms. Perry asking if other quotes were obtained, all yes motion carried.
