Friends of Culture in collaboration with Lady Peppertree will be hosting the second annual Curry With A Flavor Festival on Saturday, June 4th, 2022, from 10:00 a.m. to 10:00 p.m. The event will be held in Crescent Park, 2300 North Peters St., New Orleans, La 70117.

We are requesting that you participate in this authentic event.

PLEASE READ THE INFORMATION CAREFULLY.

Set up time is 10:00 a.m. – 12:00 noon. Break down time is 9:00 p.m. -11:00 p.m.

VENDOR FEES:

Food \$550

Merchandise \$400

Non-Profit \$300

Every vendor will need a permit from City Hall at the cost of \$50. We will inform you when it's time to apply for the permit. The permit can be paid with Cashier's Checks or M.O's only.

DEADLINE:

The deadline for applying will be Friday, April 15, 2022, at 5:00 p.m. There will be no exceptions for late applications.

RULES:

Each vendor will be issued five wrist bands in their package, and they should be worn throughout the day in the booth. Any additional helper you bring must purchase an admission fee ticket. These wrist bands will be in a different color. We are requesting the names of all your helpers.

Every vendor is responsible for their own tables, chairs, masking tape, Sternos, lighter, and electrical cords. The tent must be fireproof, and each space will be 10'x10'.

An ABC restaurant type fire extinguisher must be displayed in every booth for fire marshal's inspection.

NO OPEN FLAMES UNTIL THE FIRE MARSHALL ARRIVES.

A hand washing station must be set up in every booth. (A five-gallon water container with a spout, and a five-gallon bucket as a catch basin). You must have soap & paper towels. Please have hand sanitizer on your table as well.

There will be no selling of alcohol, soft drinks, and water at your booth. **CURRY WITH A FLAVOR FESTIVAL will be the only vendor with a liquor license.**

All vendors are responsible for their parking.

All vending spaces are to be kept clean during and after the festival. Please protect your ground space from grease and oil. Bring an old bucket or container to transport your old oil with you when leaving the site.

There will be a vendor coordinator on-site to answer all your questions and concerns. She has full authority to close down any vendor who fails to follow our rules.

This is a non-smoking environment.
