Vendor Information 2021

Reservations are now being taken for vendor space at the 2021 Butler Autumn Classic. This is a great opportunity to bring you together with your best customers. This will be for the two AKC All-Breed dog shows offered on the Lawrence County Fairgrounds by the Butler County Kennel Club on Saturday, September 25, and Sunday September 26, 2021. Local breed clubs will be having supported entries; BCKC will be offering competition for the National Owner Handler Series and 4-6mo Puppy each day.

The location (Lawrence County Farm Show Grounds, Rt 108, New Castle, PA 16101) will be available for setup after noon Friday, September 24, 2021. Vendors will be located in an area opposite the rings. Setup is on grass although there may be some sand/gravel in the area also. Each vendor is responsible for paying fee even if sharing tenting provided by vendor in adjoining space (No sub-letting).

Fees cover the entire weekend, setup on show days must be prior to 8:30 am or after 4:30 pm. Vendor not required to be on-site both days, but no fee reduction will be given.

Vendor registrations will be processed on a first come first served basis, Electric required, Date Received and Postmark date. BCKC reserves the right to limit the availability of spaces with and without electric. If you request power please also indicate what your preference is if no spaces remain with electric available.

Some spaces have limited room behind them for only a standard truck or car, maximum depth of 35 ft. will be allowed for each booth where available (eg. Booth 10x10 with a 10x25 parking area behind). Please note on the registration form if you need additional parking away from your booth or an RV space. RV parking can be accommodated but being adjacent to your booth space is not guaranteed. As much as we would like to provide an RV or camping spot with your set up fee BCKC is being charged for both spots by the fairgrounds. Nothing is included "free" with our rental of this facility.

For Safety Reasons, Please do not allow your customers to drive around the main dog show pavilion during show hours.
