On the despair side, we saw the worst H₂ refueling station uptime since Sept. 2021; at one point 65% of stations were offline. We saw, and ourselves experienced, the tremendous frustration of FCEV drivers, hearing often, "Love the car, but the fueling hassles have become impossible."

Still, it was a month of great optimism. As reflected by the quote above, there is an understanding of our frustration, and strong support for fixing the problem, from Chairperson Newman and the other Senators of the Select Committee on Transitioning to a Zero-Emission Energy Future.

Bobbie and I completed our Discovery Road Trip (photos below) with a meeting with Erik Brahms, of the office of Assemblywomen Megan Dahle, last Monday. In addition to that meeting, we had the opportunity to talk to Tadashi Ogitsu (H2 Researcher and FCEV driver), Andrew Martinez (CARB), Cory Shumaker (Hyzon and FCEV driver), Alexus Merino (City of Lancaster), Keith Malone (RE Plus and FCEV driver), Erica Lucia (Office of Senator Newman), Jackie Birdsall (Toyota and FCEV driver), Steve Mirkin (FCEV driver), Bill Elrick (Hydrogen Fuel Cell Partnership and FCEV driver).

Since we have been busy with our Road Trip this month, we were not able to get a full newsletter complete before the end of the month. Stay tuned in the coming months for reports and features on all of the above, plus more detail on other reasons for great optimism, including the <u>UC Davis Study</u> (and the need for Light Duty/Heavy Duty collaboration), the possibility of an H₂ Advisory Committee, the improving prospects for speedy station permitting, the <u>South Korea Story</u> (If we build it, they will come), the intriguing history of Governor Schwarzenegger's involvement in FCEVs, and much more!
