USE: Apply to face in the evening and massage until completely absorbed.

FUNCTIONAL SUBSTANCES

PROPANEDIOL: It is a natural ingredient that comes from the fermentation of glucose; it has solvent, emollient and humectant properties.

REGENINE: Ingredient bioliquefied by a mix of fruit acids (Apple, lemon, grapes) and wheat bran. In vivo and in vitro tests show that this active ingredient promotes skin renewal (55% in three days and 83% in six days) able to softly remove the cornecitis by the stratum corneum.

CERAMIDES NP+AP+EOP: Lipids naturally present in the epidermis used in cosmetics to restore and maintain the skin barrier and protect

the skin from external aggressions, they also have a strong moisturizing power.

oLIVE OIL BIO: Full of polyunsaturated fatty acids including oleic, linoleic, palmitoleic, and myristic acid, it performs a protective, antiwrinkle and seborestitutive function, as well as important actions at the level of skin trophism, stimulating the reparative processes of the epidermis and dermis. Thanks to the presence of vitamin E and carotenoids it has antioxidant properties, protects against the harmful action of free radicals and prevents the aging effects. It deeply moisturize the skin and regulates its natural hydration system. It also has a soothing action on redness and irritation and it is well tolerated even by the most sensitive skin.

VITAMIN E: Vitamin E and its esters have a high antioxidant activity, because they are able to reduce the reactivity of free radicals, stopping the cascade of events that determine oxidative stress, which causes damage to cells.

LACTIC ACID: Lactic acid is an acid belonging

to the category of alpha hydroxy acids, substances able to break bonds that are created between keratinocytes, helping skin peeling and cellular tournover. It is also an excellent moisturizer. Also suitable for skin that tends to redden easily.

WARNINGS:

- Keep out of reach of children and away from heat and direct sunlight.
- Avoid direct contact with eyes and mucous membranes.
- Not suitable for children under 3 years of age.
- Close the container after use.
- Avoid sun and UV lamp exposure after use.

STORAGE

Optimum conditions: store the product in well-ventilated and dry place, away from light and heat sources, at temperatures between 15 °C and 25 °C

TRANSPORT

Optimum conditions: the product should be carried at temperatures between 15 °C and 25 °C, away from light and heat sources.

Special provisions: the product is not classified as dangerous. Therefore, transport does not have to follow the provisions of ADR (road), RID (rail), IMO (sea), ICAO / IATA (air).
