GENERAL INFORMATION

Product description: Practical single-use patches for the eye contour area with unique and functional texture thanks to a natural polymer: carrageenan. This 100% natural polysaccharide found in Chondrus Crispus, a kind of red seaweed, forms an ultra-fresh film-forming gel that perfectly envelops the eye contour area with targeted action to restore a rested and bright appearance. Enriched with Annona Cherimola Extract, originally from South America, with a relaxing and anti-fatigue effect similar to CBD; Rooibos extract (red tea), very rich in antioxidants; Hyaluronic acid which is able to retain water in the skin layers playing an essential role in regulating skin hydration.

Ingredients: Aqua (Water), Glycerin, Annona Cherimola Fruit Extract, Carrageenan, Panthenol, Amorphophallus Konjac Root Extract, Aspalathus Linearis Leaf, Sucrose, Phenethyl Alcohol, Sodium Levulinate, Sodium Anisate, Sodium Hyaluronate, Sodium Citrate, Citric Acid, Phenylpropanol, Sodium Dehydroacetate.

USE: Apply the patches under the eyes and make sure they adhere perfectly to the skin. Remove after 15 minutes.

FUNCTIONAL SUBSTANCES

CARRAGEENAN: this polysaccharide found in Chondrus Crispus (a kind of red seaweed) combines with water to form an ultra-fresh film-forming gel that perfectly envelops the eye contour area with targeted action.

ANNONA EXTRACT: a fruit from Cherimoya tree, originally from South America, that has been cultivated by the Inca people. This extract has a relaxing and anti-fatigue effect similar to CBD, helping the skin to counteract several types of stress.

ROOIBOS EXTRACT: Rooibos, from the Acacia family, is a plant growing exclusively in South Africa. It is very rich in antioxidants and has soothing properties.

HYALURONIC ACID: it is one of the most important components of the skin. It is able to retain water in the skin layers, playing an essential role in the integrity of the skin structure and in regulating skin hydration.

WARNINGS

STORAGE

Optimum conditions: store the product in well-ventilated and dry place, away from light and heat sources, at temperatures between 15 °C and 25 °C.

TRANSPORT

Optimum conditions: the product should be carried at temperatures between 15 °C and 25 °C, away from light and heat sources.

Special provisions: the product is not classified as dangerous. Therefore, transport does not have to follow the provisions of ADR (road), RID (rail), IMO (sea), ICAO / IATA (air).

(For cosmetic products that can be classified as dangerous - e.g. flammable perfumes, aerosol products, hair dye products, hair removal products, etc. - transport must be carried out by authorized companies, in accordance with ADR / RID / IMO / ICAO / IATA provisions. Eye contact: in case of accidental contact, rinse with plenty of water. If eye irritation persists, seek medical advice.

Ingestion: in case of ingestion of excessive amounts of product, seek medical advice.

DISPOSAL CONSIDERATIONS

Empty containers may be disposed of after use in accordance with the labelled instructions.

PRODUCT VALIDITY

In compliance with Regulation (EC) No 1223/2009, the indication of the expiration date shall not be mandatory for cosmetic products with a minimum durability of more than thirty months. For such products, there shall be an indication of the period of time after opening (PaO) for which the product will remain stable and safe for human use after it has first been opened. This information shall be indicated by the symbol shown in point 2 of Annex VII of this Regulation, followed by the period (in months and/or years).

According to stability testing, this product has a shelf life longer than thirty months: the assigned PaO is: *see product label*.
