## **GENERAL INFORMATION**

**Product description:** Delicate two-phase make-up remover formulated without perfume\*\* and with a compatible ocular pH to easily remove make-up, without irritating the eyes and the eye contour. Formulated with 90% of naturally derived ingredients including Aloe and Chamomile with well-known soothing and refreshing properties, emollient Rice Bran Oil and toning Pale Rose distilled water. Thanks to its small size, high-performance hydrolyzed Hyaluronic Acid keeps the skin supple and moisturized.

**USE:** shake the product and pour on a cotton wool pad, cleanse the eyes and rinse.

## **FUNCTIONAL SUBSTANCES**

**ALOE VERA GEL:** it contains polysaccharides with D-glucose and D-mannose, phytosterols, vitamins, enzymes, trace elements and amino acids. Aloe juice basically moisturizes and soothes the skin. Its gel creates a protective film on the skin enabling its moisturizing action. Aloe reduces skin redness and has soothing and cicatrizing properties.

**PALE PINK ROSE WATER DISTILLATED:** toning, refreshing and soothing effect

**RICE BRAN OIL:** rich in tocopherols or tocotrienols, vitamin E, phytosterols and  $\gamma$ -oryzanol, it has strong moisturizing, emollient and soothing action. It has

deeply nourishing effects without altering the natural pH of tissues

HYDROLYZED HYALURONIC ACID: obtained from the hydrolysis of high molecular weight hyaluronic acid with higher level of solubility and absorption properties. Thanks to its small size, it reaches the deepest layers of the skin and ensures better hydration, increasing the biomechanical properties of the skin. Therefore, it facilitates an increase in skin elasticity and firmness and a reduction of the microrelief (anti-wrinkle action) with filling and plumping effects.

## **WARNINGS**

#### **STORAGE**

**Optimum conditions:** store the product in well-ventilated and dry place, away from light and heat sources, at temperatures between 15 °C and 25 °C.

## TRANSPORT

**Optimum conditions:** the product should be carried at temperatures between 15 °C and 25 °C, away from light and heat sources. **Special provisions:** the product is not classified as dangerous. Therefore, transport does not have to follow the provisions of ADR (road), RID (rail), IMO (sea), ICAO / IATA (air).

(For cosmetic products that can be classified as dangerous - e.g. flammable perfumes, aerosol products, hair dye products, hair removal products, etc. - transport must be carried out by authorized companies, in accordance with ADR / RID / IMO / ICAO / IATA provisions. ## **PRODUCT VALIDITY**

In compliance with Regulation (EC) No 1223/2009, the indication of the expiration date shall not be mandatory for cosmetic products with a minimum durability of more than thirty months. For such products, there shall be an indication of the period of time after opening (PaO) for which the product will remain stable and safe for human use after it has first been opened. This information shall be indicated by the symbol shown in point 2 of Annex VII of this Regulation, followed by the period (in months and/or years).

According to stability testing, this product has a shelf life longer than thirty months: the assigned PaO is: see product label.
