### GENERAL INFORMATION

**Product description:** A rich texture that melts onto the skin to visibly reduce wrinkles, under eye bags and dark circles (**actions in vivo tested on 30 volunteer women aged between 18 and 55 years**). Formulated with draining liposomal Escin, for an anti-swelling effect, nano-encapsulated Niacinamide and Tranexamic acid to counteract dark circles, antioxidant Black currant, Moringa oil and Hyaluronic acid. This balm is unique thanks to Homeostatine™, an active complex of two natural ingredients developed through an innovative technological process. **DDS-TRANEXAMIC ACID+NIACINAMIDE:** active ingredients in DDS (Deep Delivery System) nano-vesicles, an innovative technology for the release

of active ingredients in depth, ensuring maximum absorption and enhancing the effects of the active ingredients. Tranexamic acid is known in scientific literature for its activity on microcirculation (vasoconstriction) with a lightening effect on dark circles. Niacinamide has antioxidant, lightening properties and prevents the appearance of wrinkles.

**ESCIN IN LIPOSOME:** it has vasoprotective and vasoconstrictive action counteracting edema formation: it increases capillary resistance, reduces vessel permeability, thus facilitating the removal of accumulated interstitial fluid.

### HYALURONIC ACID WITH HIGH MOLECULAR WEIGHT:

it has a structural and moisturizing function because it is able to bind many water molecules. Being a large molecule, it stays on the epidermal surface creating a film reducing TEWL with the proper hydration and elasticity level.

**BLACK CURRANT:** rich in antioxidants contained both in the fruit and in the leaf extracts, it protects structures and tissues, especially skin and cardiovascular ones, from the harmful action of oxidizing species.

**MORINGA OIL:** rich in omega 3, vitamins A and C and isothiocyanates against irritation which have extraordinary anti-aging properties supporting the skin undergoing stress due to age. It also fights against pollution and is able to deeply detoxify the skin.

**SHEA BUTTER:** it is rich in triglycerides and has emollient, moisturizing and regenerating properties on skin barrier. It makes the skin firm

and supple and has antioxidant action thanks to vitamin E.

**SQUALANE:** it protects the skin, thanks to its ability to regenerate the lipid film that prevents aggression by external agents, and has moisturizing action, reducing water evaporation from the deeper epidermal layers (TEWL).
