SSB 5691 was passed by the House Health Care and Wellness Committee with a minor amendment and is now to the House Rules Committee. The Rules Committee will decide whether the bill should be considered by the full House and we need you to urge them to do so

This is a big ask: please send the same message to 24 different email addresses. The bill needs to be voted on in the next week, so please make this a priority in the next few days.
