#### WACCRA PRESENTS LEGISLATIVE GOALS TO STATE REGULATORS

The regulatory committee charged by the 2023 Legislature to develop recommendations for CCRC regulation is holding stakeholder meetings this month. WACCRA's meeting was held February 5, 2024, and included representatives from three agencies:

- Department of Social and Health Services (DSHS),
- Office of the Insurance Commissioner (OIC), and
- Attorney General's Office (AGO)

The discussion focused on the implementation of the 2022 OIC report. WACCRA recommended some specific consumer protections for CCRC residents. We also shared data from our recent member legislative priorities survey.

The presentation was well received with accolades that the presentation was well organized, informative, and thorough.
