VENDOR AGREEMENT

Host/Organizer: IAMSK (the "Host"), located in Nashville, Tennessee, and

1. Event Details

- The Vendor is granted permission to participate as a vendor at the:

2. Vendor Space and Setup

- Vendor spaces are limited and assigned on a first-come, first-served basis upon completion of this Agreement, Host approval, and full payment.
- The Host will provide one (1) 8-foot oblong table covered with a black tablecloth and two (2) chairs per vendor space. If no table is required, the Vendor will receive equivalent floor space. Food and drinks available at the event, is also available to the vendors.
- Setup: The Vendor may begin setup 1.5 hours before the Event doors open. All setup must be fully completed at least 15 minutes before doors open.
- The Vendor must keep their space neat, safe, and free of hazards during the Event.

3. Cleanup and Departure

- The Vendor must completely clean up their space and remove all belongings, trash, and equipment within 1.5 hours after the Event officially ends.
- Failure to comply may result in additional fees or restrictions on future participation

4. Payment

- The Vendor fee is \$50.00 (the "Fee"), which is non-refundable once paid.
- Payment must be made online via electronic payment through the Host's website ([IAMSK Vendor Agreement](#)) only after receiving written approval from the Host.
- Approval is required before payment to secure the space. Spaces are not guaranteed until payment is received and confirmed.
- The Fee covers participation for the Event date only. No refunds will be issued for any reason, including cancellation by the Vendor, non-attendance, or Event changes/cancellation by the Host (unless otherwise agreed in writing).

5. Vendor Responsibilities

- The Vendor is solely responsible for all goods, services, sales, taxes, permits, licenses, and compliance with applicable laws while participating in the Event.
- The Vendor must provide their own supplies, products, signage, and any additional equipment beyond what the Host provides.
- The Vendor agrees to conduct business courteously and professionally.

6. Liability and Indemnification

- The Host and the Event facility are not responsible for any damages, theft, loss, or injury to the Vendor's property, equipment, goods, or persons caused by the Vendor, other attendees, or any third parties.
- The Vendor assumes all risk associated with participation and agrees not to hold the Host, its officers, staff, volunteers, or the facility owner/lessee responsible or liable for any personal injuries, property damage, losses, or claims arising from the Vendor's participation in the Event.
- The Vendor agrees to indemnify and hold harmless the Host from any claims, damages, or liabilities arising from the Vendor's actions, products, or services at the Event.

7. Approval and Termination

- The Host reserves the right to approve or deny any Vendor application in its sole discretion.
- The Host may terminate this Agreement and remove the Vendor from the Event at any time without refund if the Vendor violates any terms, engages in unsafe or inappropriate behavior, or fails to comply with setup/cleanup rules.



8. Governing Law This Agreement shall be governed by the laws of the State of Tennessee. Any disputes shall be resolved in courts located in Davidson County, Tennessee.

9. Entire Agreement This document constitutes the entire agreement between the parties and supersedes any prior understandings. Amendments must be in writing and signed by both parties.
