RANGE SAFETY RULES AND INSTRUCTIONS

1. The rules of safe gun handling must be observed at all times.
 - a. Always keep muzzle pointed in a safe direction.
 - b. Always keep finger off the trigger until ready to fire.
 - c. Always keep the action open and gun unloaded until ready to fire.
2. Any shooter will be free of alcoholic beverages for at least eight hours.
3. There is absolutely NO SMOKING in the range area.
4. Firearms may only be handled while in range area. All guns in meeting room area must remain cased or holstered. A holstered/cased gun is considered safe.
5. Shooters must shoot in the lane they are in and from the line only.
6. Targets should be fired at 50' and should not exceed 24" in height.
7. Members are totally responsible for their guest.

The remaining rules are posted in the clubhouse and where given to each member in the membership packet upon orientation and will be adhered to.

I have read and understand these Safety and Range rules of the Acushnet Rifle and Pistol Club. I understand that violation of these rules may mean forfeiture of my membership.

(B) I INDEMNIFY, HOLD HARMLESS, AND PROMISE NOT TO SUE THE OWNER for any and all liabilities or claims made as a result of participation in this activity whether caused by the negligence of release or otherwise.
