RANGE SAFETY RULES AND INSTRUCTIONS

- 1. The rules of safe gun handling **MUST BE ALWAYS OBSERVED**.
 - a. Always keep muzzle pointed in a safe direction.
 - b. Always keep your finger off the trigger until it is ready to fire.
 - c. Always keep the action open and guns unloaded until it is ready to fire.
- 2. Any shooter will be free of alcoholic beverages for at least eight hours.
- 3. There is absolutely NO SMOKING in the range area.
- 4. Firearms may only be handled while in range area. All guns in the meeting room area must remain cased or holstered. A holstered/cased gun is considered safe.
- 5. Shooters must shoot in the lane they are in and from the line only.
- 6. Targets should be fired at 50' and should not exceed 24" in height.
- 7. Members are totally responsible for their guest.

The remaining rules are posted in the clubhouse and were given to each member in the membership packet upon orientation and will be adhered to.
