
ANNUAL REPORT

Today, the current service delivery model consists of two administrative staff members, seven part-time personnel, and fifteen full-time personnel. These employees complement each other and make the service exceptional.

Automatic Aid Responses Received by Munson Fire Department: 43 times in 2023, 2.7% of total incidents, of which 3 incidents were confirmed fires in a structure, and 1% of total automatic aid responses Munson received were confirmed fires.

Automatic Aid Responses Given by Munson Fire Department: 107 times in 2023, 6.8% of Total Incidents, Mutual Aid, and Automatic Aid, of which Munson Fire responded, 37 were confirmed fires or fires in a structure, 50% of the total Automatic Aid responses given.

Mutual Aid Responses Received by Munson Fire Department – 22 times in 2023, 1.3 % of Total Incidents.



Total EMS incidents were 1134, with 1195 patients evaluated.

86% of the transports were to University Hospitals Geauga Medical Center.

13% of the transports were to Cleveland Clinic Hillcrest.

2% were transported to Lake Health Tripoint or other facilities.

Collection on average of \$329.04 per transport.

92% of the transports are to University Hospitals Geauga Medical Center.

Local businesses, such as Interstate Towing and Walters Towing, continue to donate vehicles for Munson Fire to practice modern vehicle extrication and live fire suppression efforts. Techniques and stabilization. These critical procedures are continuing to evolve due to modern vehicles and the push for electric hybrid models. This makes for some safety challenges.



Munson Fire Department is proud to announce that throughout the 2023 year, we completed and conducted a total of **3847.25** in-house and professional development hours. Highlights were a paramedic refresher course offered by University Hospitals in January 2023. With the assistance of our medical director, Dr. Andrew Garlisi, Munson was one of the first departments in Geauga County to have all its paramedics trained in RSI (rapid sequence intubation).

Fire Inspections

Munson Township is proud to be the home of 93 commercial dwellings that house 137 businesses. These include all types of businesses, such as three nursing homes/assisted living facilities, three schools, several medical office buildings, some manufacturing, and the County Safety Center/Jail, just to name a few.

The Fire Prevention Bureau strives for 100% compliance in the commercial buildings that we protect. The bureau's main function is to enforce the applicable fire codes that are in place to prevent harm and reduce the severity of fires in public places within Munson Township. The codes utilized are the Ohio Fire Code and the Ohio Basic Building Code.

As stated above, the bureau's kitchen hood suppression tests, fire alarm tests, and fire sprinkler tests are observed and witnessed. Some of these tests are performed yearly, semi-yearly, and quarterly, depending on the occupancy of the building.

The hours dedicated and spent on fire prevention for 2023 were just over 2,100 hours. These hours account for the inspections, phone calls, and meetings with various architects, builders, engineers, and owners to complete the mission.

Our Bureau is headed by Douglas Riedel, CFI, and supported by Chief Mike Vatty. The Bureau is further assisted by the three Battalion Chief's for company inspections. The fire department is very fortunate to have eleven others who are state-certified fire inspectors to assist.

In the year 2023, the township saw a slight increase in township growth, two commercial businesses and several residential dwellings.

The Bureau's other activities also include: Fire Inspector Doug Riedel fire prevention education. Doug attended the following classes:

PUBLIC EDUCATION

The Munson Fire Prevention Bureau, along with the fire department personnel, are also responsible for providing fire prevention and life safety programs to the residents and businesses of Munson Township. This was the first time BC Ferroni, along with his shift, conducted CPR and Stop the Bleed classes for Notre Dame Cathedral Latin's facility, training staff and faculty.

Some of the other activities included: residential and commercial Knox Box Program, CPR training, Vial of Life program, smoke detector program, carbon monoxide detector program, fire safety classes at the elementary schools, community days, Township Flee Market, Munson Fishing Derby, fire department Halloween drive-through, truck or treat parties, and block parties.

Fire Prevention Accomplishments

There were major accomplishments made during the year. One addition was the electric car charging station requirements for the township. In conjunction with the Munson Zoning Inspector and the Township Zoning Commission, items were added to the Township Zoning regulations for their instillation. In addition, all solar panels that are applied for and granted by the zoning inspector are now recorded and entered in our county CAD dispatch system. Now our responding units are aware of their presence and their disconnect procedures. A Stop the Bleed class and a CPR class were conducted for the members of the Munson Road Department. The road department is now equipped with the essential equipment and trained to handle initial lifesaving procedures. Munson Township Trustees also purchased for the road department two external defibrillators compatible with our equipment.



Fire Prevention Plans for 2024

Three years ago, a Citizen's Fire Academy was planned. This would have been a series of six weekly classes. This was designed to educate the residents of Munson about what '**THEIR'** fire department is all about. The citizens fire academy would include lectures and practical drills Munson Fire personnel perform. We are looking forward to scheduling this event.

The Munson Fire Prevention Bureau is responsible for providing fire prevention and conducting life safety education programs. Some of this training includes fire safety classes, CPR training, Stop the Bleed, the Vial of Life program, a smoke detector program, a carbon monoxide detector program, and Knox Box programs. Munson Fire Department also provides and participates in Community Days, Trunk or Treat, block parties, and hosts a Halloween event for the community.

Pump Test and Ladder Tests

All fire apparatus was maintained to 1901 NFPA standards; recent changes in the ladder test vendor indicated several ground ladders that needed attention to pass and comply with the standards. These were simple safety-related items, such as stickers and heat labels, that were expiring; all have been replaced and passed. Ladder testing, including the aerial 4044, was performed by The Aerial Guy out of Akron, Ohio. All Munson Fire Department fire pumps were tested to NFPA 1901 standards and passed by a new vendor; other area departments have used D and T Fire Services also.

Major Vehicle Repairs Performed

During 2023, both 4022 and 4044 required repacking of the fire pump. This is a wearable item that was adjusted out of its normal range. The pump packing is a sensitive seal that is lubricated by water and adjusted to allow the pump to create a vacuum and draft water. Other than these repairs, no other extensive vehicle repairs were needed. Normal repairs were routine repairs such as tires, annual preventative maintenance, and lights.

Vehicle Replacement



Following our vehicle replacement schedule, the next vehicle for replacement is 4054. This is an AEV medium-duty rescue squad. Currently, a 1998 with miles. Typically, these rescues cost around \$250,000 to replace. The current market value for replacement is \$330,000. These are bought on a five-to-seven-year lease to purchase program paid out of EMS collections revenue. Our plan is to extend this to eight years and investigate the refurbishment and chassis of the patient compartment.

Burton Fire is now performing this on one of their vehicles and we are looking to see the outcome. Financially, this can be done for under \$180,000, making this a worthwhile viable option.

Ohio Department of EMS Grant

Munson Fire Department was awarded \$3,279.68 from the Ohio Department of Public Safety, Division of EMS (ODPS EMS). This is funded by the State of Ohio with funds generated from seat belt tickets written across the state and disbursed to agencies applying for the grant. This \$3,279.68 is significantly more than received the



previous year. State funding during COVID years was significantly cut. Now, this amount is back in line with trending years for replacing non-disposable equipment with grant funds.

Munson Fire Department also received two ventilators from University Hospitals. These ventilators are more advanced than our older demand ventilators we were using. Heather Hill Communities respirator department provided the training in the advanced use and maintenance for these units. The new units can provide CPAP (continuous positive airway pressure), BIPAP (bilevel positive airway pressure) and assist with ventilations to an unconscious patient who is or is not breathing on their own.

Capital Improvements for 2024

Current Life Pak 15 cardiac monitors are beyond their service life. The manufacturer no longer supports their annual maintenance contracts or any serviceability. Parts for these units have become obsolete. During 2024, we are looking to apply for grants to upgrade and replace these two life-saving devices. Current pricing per unit is more than \$45,000 each. These devices are essential for the current standard of care and service level expected by Munson Township residents and the care provided and supported by University Hospitals. Newly upgraded cardiac monitors should have a service life of fifteen years and provide state-of-the art supportive cardiac care.

Munson Fire Department is researching a safety grant with the Ohio Department of Transportation. The grant is a safety grant for providing trauma care and minimizing responses on our roadways. The grant would apply for preemption at the following intersections in the Township: The intersection of Bass lake and Mayfield, the Mayfield and Ravenna intersection, and possibly several other intersections out of Munson Township are affecting the response times to the University Hospitals Geauga Emergency Room.

Capital Building Improvements for 2024

Munson Fire Department last year met with Guardian Security to establish and price out a fire detection system in the fire station and Munson Town hall. After several conversations and plans were submitted, it was never followed through. Hopefully, we can bring this topic back to the drawing table to provide continuity for our services to the Township.
