c. Indoor Lease

- a. John Sommercamp had been looking at commercial facility options for many months and there is not a lot of inventory, and inventory available is typically much more expensive than this property. This is an opportunity to start small to determine the value.
- b. Huge gain and draw for RYSC as only two other clubs in the Sacramento area have indoor facilities. Will allow RYSC to stay competitive.
- c. Would be used for foot skill training, not games. The indoor facility would allow camps to continue when not possible due to outdoor conditions (heat/fires/etc.)
- d. Cost about \$4,200 per month, and \$6,000 upfront for used turf.
 - PYSL refund would be used to cover costs. Comp fees would also be increased to help cover indoor facility costs.
- e. Facility can house 2 larger teams, and 1 small team at once.
 - i. If things go well with the first space, the owner has a second space that could be allow for expansion.
- f. Motion by John Sommercamp to move forward with a 1-year lease for the indoor facility out lined in the email sent by John to the board on 12/4/2020 second by Kevin Stringer. Yes-10, No-3, Abstain-2
