 - a. Motion by John Sommercamp and second by Joe Canchola to elect:
 - i. Isabel Nelson as Director of Fields.
 - 1. Yes-10, No-0, Abstain-0.

- C. Discuss Club long-term vision, including possible monthly competitive fees, Club-wide curriculum, and paid staff.
 - a. Recreational program note: any Club changes should enhance education and resources to coaches without substantially increasing program cost, as low-cost and access are critical for community soccer.
 - b. Competitive program survey: reviewed survey responses to date.
 - i. Vast majority of competitive respondents expressed a desire for enhanced, professional coaching—whether via a hybrid volunteer coach/paid trainer model (72.6%) or an all-paid-coach model (19.6%).
 - ii.80% expressed interest in implementing a competitive monthly fee to enhance quality of coaching and expand soccer opportunities
 - c. Options reviewed:
 - i. ZSoccer
 - 1. Would not operate as they have in 2021, adjustments are needed.
 - ii.Curriculum development (develop in-house versus source from professional Club, such as FCB)
 - RYSC could be the only US club with a FCB partnership. Includes feeder to Colleges (Dallas/Colorado) and MLS.
 - 2. Other professional curriculum pathways available.
 - 3. Hire Director of Coaching (DOC) with strong curricular experience.
 - iii. Direct hire of staff (e.g. DOC, age group directors, operations director, etc.): personnel would be committed to Club, available for trainings and activities, adaptive to Roseville's needs.
 - iv. Discussed size and scope of competitive program: balancing the need to be competitive at the higher level with the need to support multi-sport athletes in our unique Club.
 - d. Pursuit of indoor training facility is ongoing: Club has funds available, has put in offers on local buildings, and intends to secure a training facility for (1) enhanced recreational camps, (2) poor AQI training, (3) winter training, and (4) general futsal/skill work.
