Amy Pritchard:

- Jim continues to line the fields, based on priority. The comp fields have been completed, he has now starting on the Junction City tournament fields, and then will move on the remaining fields based on 2019 usage.
- o City is ordering more wheels for the goals, there has been a delay.
- Discussed options for storage, delivery, and payment of field paint. Amy and coaching directors will have a follow-up meeting to discuss further.

Ted Archer:
