Single time installation charge is waived if there is any additional service performed on the field within 14 days after installation or with contract. (Example: Field is installed and over sprayed at a later dates or date.)

Paint used will be water based biodegradable

Work to be performed by myself with subcontractors as needed

Prices listed include all labor, materials, equipment, and transportation costs.

Unless warranted, due to weather, air quality, or by request, fields will be painted on a weekly, bi-weekly, or as needed basis unless otherwise directed.

Field condition issues will be forwarded to the Roseville Soccer Director of Fields for extreme field conditions. (Example: Field is overwatered/marshy to the point of being unpaintable, Mowing damage, etc...)

Initial field installs will be prior to city goal settings is preferred unless goals are set permanently.

Field access by vehicles or equipment might be needed, and as such keys or pre opened areas might be required.

Some fields may only need touch up work. I reserve the right to only levy partial charges for the work done on those fields.

Location, size, and set up options will be made for maximum safety of the players, client, and contractor. I WILL NOT install any field that is less than minimum standards for safety. Typically, 9 feet is minimum from any side/goal line, but may vary depending on objects and insurance requirements.

Income Statement vs. Budget

- Year to date net income of <\$2,240> driven primarily by Registrar fees and expenses, field rental, and team photos (invoice from 2018 activity paid in 2019).
- This is offset by a non-cash miscellaneous income item of \$26,455 which represents the reversal of the Game Officials Junction City referee batch from 2017.
 - We wrote off the Account Payable and must recognize as income (debt forgiveness).
 - o If Game Officials ever gets back to us, we will reverse and expense the item.
- As we progress further in the year, income and expense variations to budget will be analyzed
