By making this position an independent contractor we avoid having employees, taxes, payroll, human resource handbooks, Workers comp insurance, all of which will increase our costs. It is easier to make this a third-party vendor, put this out to bid, and remove the registrar from a board position. RYSC will go out for bid for a 3rd party vendor. RYSC By Laws will require updates.
