

Professional Review of Operations

Have you ever wanted a closer look? Then ACCA PRO (Professional Review of Operations) can help! ACCA can examine your field, shelter and administrative operations to include current deployment of resources (budget, equipment, training and staffing) and suggested productivity improvements. If you do not routinely evaluate your animal control/care program, then you are missing out on a valuable resource. This is true whether you manage your own program or contract for this special training or expertise. Hiring a consultant or management audit team, such as ACCA, to review your agency's performance can help you determine how well your program is addressing your particular community's animal control/care needs.

But what are your community needs? These may be reflected in the ordinances and statutes you enforce (if these are not outdated) and in the programs of local animal welfare organizations. If located in a rabies endemic area you may be most concerned with vaccination and licensing effectiveness. Although urban programs may be most concerned with leash law violations or excessive numbers of dog bites, rural programs may be understandably more concerned with livestock losses. Perhaps conditions in your community demand or justify high profile cruelty investigation or humane education activities.

Because community animal control/care needs are almost always limited by budget, and because these needs change as communities change, agencies must periodically verify program priorities. Review with your staff your program's goals and objectives. Take the time to discuss, and answer in writing, the following questions:



- 3 Foot Pole (weight 1 3/4 lbs)
 Used mostly in kennels for handling cats and small dogs
- 4 Foot Pole (weight 2 lbs)
 The most popular pole for general use
- 5 Foot Pole (weight 2 1/4 lbs)
 Popular because of its additional length
- 28" Baton Type Pole (weight 1 2/5 lbs)
 Most useful in confined areas for handling small animals

TELESCOPIC EXTENSION POLE

- 4-6 Foot Pole (weight 2 1/2 lbs)
 Extended, it is used when additional length is needed
- Retracted, it is used as a heavy-duty restraining pole
- 7-12 Foot Pole (weight 4 lbs)
 Extended, it is used for rescuing animals from waterways, trees, storm drains, etc.
 Retracted, it is used as a longer heavy-duty restraining pole

- 1. "What are our community needs? What are we in business for?"

Additionally, community perspectives should be solicited, starting with the concerns of your governing body and funding sources. A personal discussion with each member of this body will also help to insure that they understand the entire scope of program responsibilities (hopefully, as a result subsequent budget decisions will less likely be made on the basis of individual complaints, emotional issues, or personal prejudices). ACCA can assist your agency in determining local perspectives on local animal control problems.

Approach to the Study

- A review of court preparation and appearance of those involved.
- An analysis of the adequacy of current levels of office automation, communication and computer support systems.
- An examination of shelter operations, including facility construction, operations, record accountability, injured animal protocol, policies and procedures, euthanasia and adoptions.
- Examination of the effectiveness of community relations, i.e., programs, volunteers, etc.
- An analysis of the mission statement for the agency and examination of the policies, procedures and workplans for each major function.
