Peter reinforced a huge thank you to the volunteers in the tech and music space. No questions from the floor.

Chair: Exciting what's happening at St John's. Feedback from the Bothe's regarding how well Pastor Mal supported the school community following the tragic death of a student last year. Also, many positive comments have been received regarding Peter & Bronwyn's impact at the school. MoU needs to be resolved – hopefully the partnership moves forward harmoniously. Treasurer expressed concern over the amount of money requested for the tech budget. It is hoped the St Luke's congregation is supportive of creating an equipment fund, as the general budget will likely not be able to cover the expense. St John's to fund part of Peter's salary – numbers do not equate at present, to be resolved shortly.

CHURCH COUNCIL TREASURER'S REPORT - Terry:

As per Book of Reports & PowerPoint presentation (refer to printed copy of presentation slides).

If we want the work of the church to continue, we need to support it financially as a congregation:

- 2 main parts of financial contribution are the offering and the lease of 440 Guinea Street. Need to fund \$126,000 just for salaries support coming from St John's (Peter) and District Funds (Bron MoU). Exercise class (hiring the hall) boosts income and gratitude extended to the Government for supplying JobKeeper and business support funds
- Interest rates are down
- Trading table income has allowed us to send money to support ALWS and some more local causes but has been impacted by Covid
- Christmas action appeal funds have decreased dramatically impact of Covid https://netorgft8325810-
- Incoming AV funds from the District funded most of the service streaming costs
- Malcolm's district funding has ceased
- No income from Frontier (no incoming course fees)
- Church cleaning has been a big expense to consider cleaning roster?
- Big printer in the office was on its last legs and we've acquired 2 new printers (convenience). Big printing jobs are done at OfficeWorks (funeral programs etc)
- Commercial lease has been of benefit (as opposed to domestic lease) as rates
 etc are all paid by the tenant. We are paying agent fees and there was some
 expense to get it ready to rent out
- Conference expenses increasing now with conferences happening again (post covid)
- Intention to get property up to scratch post selling of Macauley Street these expenses should decrease now
- Fire check and testing and tagging is a large expense, but it has to be done legal requirement
- Online giving is encouraged due to the expense of the offering envelopes and less work for volunteers (counting money etc)
- Each year \$10,000 paid to the District
- Deficit \$20,000 first year of covid, deficit \$60,000 last year should get over
 \$20,000 back for Bron's wages
- Need to buy some banners
- \$358,600 from Macauley street sale has been used for improvements to the hall and manse (new roof \$36,000). Guinea street set up and no rent income prompted \$53,00 transfer to the general account. \$27,000 was spent on music and sound (licences etc). Recruiting music director cost \$8,000 (chiefly travel

and accommodation). \$160,000 spent since 2019 on salary and related expenses.

- Peter's contract was extended to June 2022 we all want Peter and other staff here, so we need to do our best to make sure we can make it happen
- Tech and streaming made such a big difference during the pandemic it's been very good to keep the congregation able to access church services during the height of Covid
- No budget has been completed for this current year as the biggest item is salaries and we don't know exactly what is happening with the church in the call process, nothing is finalised for Bron from the District, nothing has been received from St John's regarding Peter's salary Questions from the floor:
- Can you please clarify what the MoU is and how it affects Bron's funding? Terry explained the MoU is a Memorandum of Understanding between the stakeholders involved in the proposed Jindera church plant (St Luke's, St John's and the Burrum Parish). Once the document has been passed by all parties, the District will reimburse all of Bron's salary (currently being paid out of St Luke's funds)
- Are there any bequeathed funds left or has it all been spent? The most recent bequest (Trevor Klein) has been spent and covered in previous reports, which are available for viewing if anyone wishes to review
- When we call a full-time pastor, will the wages expense increase? Would the wage structure be higher? To date, we've been better off, Malcolm's salary has been coming from the transfer fund (& not ordained yet) the church is officially in vacancy with Malcolm as the Pastor. Initially, while we are calling, the District will be paying 50% of Malcolm's salary. It will cost more to have a full-time pastor. St Luke's can afford 1.5 salaries.

Pastor's Report – AGM, St. Luke's 2023

I have been an Interim Pastor—called to the District and made available by it—at St. Luke's since January 2023. The following report reflects my involvement in the ministry here over the last three months.

Ministry team: It is proving to be a joy working with Peter Reed and John McClelland. I am learning much from them. We meet every Thursday morning to plan for Sunday services and discuss spiritual, missional, and pastoral issues in the congregation.

The Office: We should express gratitude for the effort put in by all those involved with the office administration of the congregation. They are an important cog in our pastoral support offered to St. Luke's. Please keep them in your prayers. I am particularly grateful for Nikki Spaans our new administration officer and look forward to working with her.

Church Services: We have a sufficiency of musicians/singers in the congregation, but of course more would be even better. I feel that we have a good blend of contemporary and traditional forms of worship in our Sunday services. I must express gratitude to those who assist with our services. You are doing the work of the Holy Spirit. Lent was a fulfilling time for both myself and the congregations of St. Luke's and St. Peter's. The midweek Lenten services were focused on the love-virtues of Christ and were well received by those that attended them. It was also a pleasure working with Pastor Peter Fuhlbohm in preparing for the devotions. Holy Week was a blessed experience.

Pastoral care group: We hold monthly meetings to reflect on the basic pastoral needs of St. Luke's members. I have been doing home and aged care visits with members of our pastoral care group. This has allowed me to get to know those with special needs. I would like to spend more time visiting the general membership, "fringe members", and "frequent visitors" over the next few months.

Funeral: I held the funeral service for Geoff Scholz in February at Alma Park.

- **Baptisms:** the baptism of Lukas Sakkas on Palm Sunday was a joy. I will hold a double baptism for Nora and Ryker Everett on 29 April.
- **Bible studies**: I assist with studies for the evening ladies guild meetings, as well as the ladies afternoon fellowship group. The theme of the studies is the fruits of the love of God.
- **St. Johns School**: I provide pastoral and theological support to Peter Reed, our church planter at St. Johns. I am also learning much from him in this regard. I feel that this church plant is an important missional opportunity for Lutheranism in the Riverina. We should therefore continue to actively support Peter as much as we can.
- **Christian education**: we have thus far not received any confirmees. I believe that some form of Christian education is important for congregational life, and am thus thinking of holding anintroductory/refresher course on Luther's Small Catechism for whoever would like to attend.
- **Men's fellowship group**: We meet once a month for a chat and brekkie at the Commercial club. I am in the process of thinking through themes for the chats for this year.
- **St. Peter's:** I will provide the necessary spiritual, theological, and pastoral support as we discern the nature of our working relationship with St. Peter's over the forthcoming months.
- **Upcoming:** Ministry and Mission Conference in June and Pastor's Conference October.
- **Personal**: I receive professional psychological support for my own self-care and healing after a marriage breakup. My children visit me every fortnight for a weekend. My PhD thesis is nearing completing with all three examiners agreeing "Pass with minor revisions for the intent to publish."

Challenges and opportunities:

- The congregation needs to think about how to establish an active children's ministry.
- Some thought needs to be put into a "young people" ministry.

- Continuing with our child-safe policies and procedures.
- Waiting for a pastor to accept a call.
- Forming relationships with the community (groups, organizations, and so on).
- I have noticed a few new faces at our Sunday services. Let us get to know these people.
- St. Luke's is an active congregation: people are genuinely involved in the life of their congregation. It also seems to me that people are open to exploring new ideas for church life. There is a good culture here. Having said so, I believe that it is important to target our resources and energy towards activities that are sustainable and creative.
- The challenges of the last three years. How are people travelling in light of those experiences?

Music, Tech, and St John's Church Plant Report

This will likely be my last official report at a St Luke's AGM. I have loved being a part of this community, and have really enjoyed working in a congregation that shows so much love for one another.

On Easter Sunday I officially started working full time as a Church Planter in Jindera. As part of that role, I am acting as a Chaplain at St John's School, providing Pastoral Care and Spiritual Support for the students, staff, and parents. With a group of volunteers from the school and wider Jindera community, I have started running Friday evening Kids Church services twice a term. The three we've run so far have been very successful, and I'd like to thank God for the amazing volunteers who He's brought together to help, including various St Luke's members!

As my new role doesn't currently included Sunday services, I plan on spending Sunday mornings visiting various Lutheran churches in the area. I hope to still spend at least 1 Sunday a month with you all. I will also be continuing to meet weekly with Pastor Will and John McClellend to pray together and support each other in ministry. If you see me around the grounds, be sure to say hi! This last year has been a time of upheaval in the music and tech spaces. The sudden departure of previous employees meant we no longer had enough volunteers for either our tech and music spaces to continue to operate in the same way. This meant that a few of our services have had pre-recorded music, and we had to stop livestreaming/recording services. However, the camera system remains installed and operational, and could be utilised in the future. As St Luke's discusses its possible shared future with St Peter's, one possible option would be to stream occasional services from St Luke's to St Peter's, to lessen the service load on the new Pastor.

I'd like to thank Leigh and Heather who have both gone above and beyond to make sure as many services as possible have had live music. Leigh and John Mac have both learnt to run some of our projection and administration software to help lesson the load on me while we didn't have a Pastor or admin personnel. I'd also like to thank Lucas, who has pretty much taken over my role as tech manager in the church. Thanks also goes to all the wonderful musicians, singers, and tech volunteers that St Luke's is blessed to have.

Thank you all for being a wonderful congregation to work for. I am excited to see what God has in store for you in the future.

Chairperson's Report 20th April 2023

During the last twelve months there have been some difficult times at St Luke's but in these times, God has given us hope and filled us with courage.

We are so blessed at St Luke's to have a congregation of members who come together each Sunday for services and at lots of other times during the week for fellowship, prayer and recreation activities because we enjoy each other's company. We look after each other, care for each other and pray for each other. Our love of God has brought us together and we continue to grow together in our faith.

During the vacancy at St Luke's many congregation members have stepped up to fill roles so that we have had continuity of services. John McClelland and Peter Reed were authorised by Bishop Bartholomeaus for sacrament and ministry and have skilfully served our congregation in presenting services. We thank John in particular, for serving us in this role and providing us with inspiring and interesting sermons.

Ian Bahr has taken Lay Reading services and other retired ministers Hayden Blaess, Ernie Kiss and Garry Kenny have also made themselves available to take services.

In October 2022 Bishop Bartholomaeus asked retired minister, Pastor Dennis Obst to spend some time taking services at St Luke's. Dennis was with us most weeks until Christmas taking services, visiting members and offering counselling and advice.

I would like to thank members of Church Council who have assisted me during the year Noel Frohling: Deputy Chair, Terry Caldwell: Treasurer, Christine Essex: Secretary, Dorothy Dunkerton and Verna McGrath: Pastoral Carers, Robert Schulz: Property Maintenance. Thanks also to Peter Reed, our Tech and Music support person.

Nikki Spaans recently commenced work as our administration support person one day per week. Nikki is learning quickly and has settled into the role comfortably. Over the next few months, you might be contacted by Nikki to update your membership details. Working With Children Check or safe Church Training details.

In mid-January Pastor Will Frost commenced at St Luke's in a relieving role as our minister until such time as a permanent minister accepts a Call to St Luke's, which hopefully will be during 2023. Pastor Frost is living in a property we have rented for our manse. He has been welcomed by congregation members and has given us some inspiring sermons to reflect upon.

The Woman's Fellowship Groups both evening and afternoon groups and Craft Group have all continued the activities they have organized to bring together members of the congregation in the name of Christ. The fellowship developed within these groups reflects their commitment to the congregation and love of our saviour Jesus Christ.

The Pastoral Carers have offered great support to members who have been sick, those who find it difficult to come to church because of mobility and members who reside in nursing homes in Albury. They have not been able to offer communion in the home. They also have assisted with delivering communion during our church services. Thank you to this team of dedicated members who unselfishly give their time to others.

The music group and organists have led our worship in music and singing each Sunday. This small group of dedicated members gladly offer their services in this area and give their time to practice each week to ensure we are familiar with the music and songs to be used each week. Thank you for your

contributions and musical talents that have assisted in highlighting our ministry and congregational life each week.

Each Thursday morning a group meet for prayer led by Ruth Grulke. This group have been praying for members and our future.

Each week there are visual presentations that appear on the overhead screen. This takes time to coordinate and prepare. Thank you to the small band of members who put this together each week.

There is another group of members who give their time to regularly supervise correctional services people to complete the mowing of lawns, sweeping and blowing leaves and make the areas around our buildings very welcoming each week. Thank you for completing this very important task that you do so well.

Over the next twelve months we will be working with Peter Reed, St John's school Chaplain on planting a new church group at the school supporting him in this role where we are able to. So there are exciting times ahead for us. We thank God that he has answered our prayers and through prayer we will continue to be able to grow our ministeries.
