COMMUNITY RELIEF

The PATH Fund's COMMUNITY RELIEF Grant Program will provide financial assistance through individual grants of \$100, \$250 and \$500 to qualifying members of the Arts & Entertainment community. Grants will cover lost income and essential expenses for those who have been affected by the Coronavirus outbreak and subsequent cancellation of hundreds of Broadway Shows, Concerts, and Live Events across the country.



These are the people who give their time and talent every year to help us raise funds for worthy charitable causes.

The PATH Fund, Inc.®, is a nonprofit formed in 2007 with a group of Performing Artists That Help, dedicated to supporting arts education. We support pre-professional training organizations with scholarships, program funding, working with aspiring talent and by presenting live music events and new works of music and theater. In times of great need, we have allied ourselves and supported notable causes including Disaster Relief, Racial Injustice and now the Coronavirus pandemic.

In response to the Broadway shut down on March 12, 2020 we knew we needed to do something for our community. There were 31 productions running, 8 new shows in previews and another 8 productions in rehearsal preparing for opening - that's over 95,000 jobs. Now months later, there is still no clear path to future of live performances. Many people in our community are having to re-evaluate what they are going to do for a living moving forward.

SELECTION CRITERIA

Each grant applicant will be reviewed by The PATH Fund's Special Grant Committee.

Grants will be awarded by The PATH Fund on an objective and nondiscriminatory basis upon reviewing the application and ascertaining any additional facts and circumstances as necessary.

- 1. Grants will be made electronically or by paper check in the form of lump sum distributions to the recipient, or as determined by The PATH Fund based on the needs of the particular recipient.
- 2. Grant recipients may be required to provide The PATH Fund with additional documentation that the grant was used in a manner consistent with the terms of the grant. All data is kept confidential and secure.
- 3. Grants issued based on the order the applications were received and based on applicants need up to the amount being given over said period of time.
- 4. Grants will be awarded once per month dependent on number of applicants and funds raised.
- 5. No grants will be made to individuals making over \$150,000 in 2019.
- 6. No grants will be made to individuals who are currently employed full time.

ELIGIBILITY REQUIREMENTS

In order to qualify for a PATH Fund's COMMUNITY RELIEF Grant, applicants must submit:

- PATH Community Relief Fund Application completed in full.
- Provide financial information to receive funds if awarded grant.
- Provide completed <u>W9 Tax Form</u>.
- Agree to post social media platforms to help PATH raise further funding.
- Proof of Participation: Copy of program, show photo, website listing, current resume and/or Proof of Union Membership.
