MISS TURQUOISE CIRCUIT 2026 CONTRACT

This contract must be executed, uploaded and emailed to mtcboard24@gmail.com, by September 26, 2025 as part of the Miss Turquoise Circuit Application. Failure to meet this requirement could result in disqualification from the Miss Turquoise Circuit 2026 competition. The hard copy of this contract must be turned into MTC Board at the 2026 MTCP orientation on October 30, 2025. This contract will take effect upon completion of the Miss Turquoise Circuit 2026 Pageant, and only when the scores have been tallied and approved by an authorized official and accepted by a representative of the Miss Turquoise Circuit Pageant/Borderland Queen Enterprises, Inc.

COMES NOW, the Miss Turquoise Circuit Pageant, hereinafter referred to as "MTCP", and ________, the winner of the Miss Turquoise Circuit 2026 Pageant, hereinafter referred to as Miss Turquoise Circuit 2026 or MTC 2026.

WITNESSETH Miss Turquoise Circuit does, in consideration of the MTCP in choosing her as MTC through the rules and regulations of the MTCP, represent as follows, to-wit:

- 1. She was born a female and is a citizen of the United States of America who resides in the state of _____ (either Arizona or New Mexico.)
- 2. She was born a natural female, has never been married, entered into a marriage contract that was annulled, or is the mother of a child.
- 3. That she will have attained the age of 18 prior to 12/31/2025 and is not older than 26 years of age as of January 1, 2026.
- 4. That she is of good moral character and has never been convicted of a crime.
- 5. That she has not heretofore authorized any person, firm, or corporation to use her name, photograph, present or future title in connection with an endorsement or advertisement of any commercial product or service, that she is not under contract or other obligation to any person, firm or corporation with respect to the title of "Miss Turquoise Circuit" and the designation herein, and further, MTC 2026 has not made any commitment or has any legal obligation which would prevent or hinder her compliance with the terms and conditions of this Agreement.

6. This is the first Miss Turquoise Circuit Pageant _	has
won. THEREFORE, in consideration of the representation	ons heretofore set forth, the Miss Turquoise Circuit
Pageant will appoint	, Miss Turquoise Circuit 2026 as she has
accumulated the highest score from all judges, as tallied	d and ratified by the MTCP.

NOW, THEREFORE, in and for the consideration of Miss Turquoise Circuit, having been designated as such and for other good and valuable considerations, does hereby agrees as follows:

- 1. That the rules of the MTCP are hereby incorporated herein as if set forth in full.
- 2. That during her reign, she shall conduct herself in a manner which shall maintain the dignity of the title herein.
- 3. That during her reign, she shall not compete for any other title without written permission of the Board of Directors of Borderland Queen Enterprises, Inc. and the MTCP.
- 4. Miss Turquoise Circuit will represent the Turquoise Circuit, as directed by the Miss Turquoise Circuit Pageant Committee and the Turquoise Circuit Board (TCB), by participating in activities such as, but not limited to, making appearances at PRCA rodeos in the states of Arizona and New Mexico, attending as many queen pageants in the two state as is monetarily feasible, as well as making community and/or public appearances as requested by rodeo committees or the Turquoise Circuit Board. However, her primary duty as MTC 2026 is to work sanctioned rodeos with stock contractors and rodeo committees in whatever capacity they request or require to insure a well-run rodeo.

- 5. MTC 2026 shall submit pictures and articles for the Miss Turquoise Circuit social media pages and/or an alternative designated by the Miss Turquoise Circuit Board of Directors/Borderland Queen Enterprises, during and after each and every appearance, and in a timely manner.
- 6. MTC shall own or have access to a horse for the entire duration of her reign, as not all rodeos/stock contractors will furnish a horse for her use. She must have the ability to haul a horse to the required rodeo; to include having access to a trailer and the ability to pull said trailer.
- 7. MTC agrees to do monthly Sponsor Shout-outs of pageant sponsors on social media.
- 8. MTC may obtain personal sponsors, subject to both prior and final approval by the BQE, Inc. Board. Personal sponsors may not be in direct or indirect competition with official pageant sponsors- meaning they may not sell the same type of products or offer the same types of services, even if marketed differently or on a smaller scale. A Personal Sponsor Form must be fully completed and submitted to the BQE, Inc. Board along with any funds collected. If the sponsorship is an in-kind, non-cash format, the sponsor must state on the form the service they are providing and the approximate value. Sponsors may indicate on the form how they would like their contribution to be designated (e.g., for travel, wardrobe, etc.), and if a designation is made, the funds must be used specifically for that purpose. BQE, Inc. will issue official tax receipts to sponsors and will disburse the collected funds to MTC on a regular basis, using a method such as a replenishable cash card or another format at the sole discretion of BQE, Inc.
- 9. Miss Turquoise Circuit 2026 shall be responsible for and expected to give/send "Thank You" letters/notes/cards in a timely manner for each and every one of her appearances to the committee and host home, should she have one.
- 10. Miss Turquoise Circuit 2026 agrees to attend the following events as part of her contract, and as many other rodeos in AZ and NM as is feasible AND within her budget.

MTC will have 4 mandatory rodeos she must attend:

- Cave Creek Rodeo in March-Cave Creek, AZ
- Prescott Frontier Days in July- Prescott, AZ
- World's Oldest Continuous Rodeo in August- Payson, AZ
- Turquoise Circuit Finals Rodeo/Miss Turquoise Circuit Pageant-Cave Creek, AZ

She will also be required to attend 3 PRCA rodeos in New Mexico and 3 PRCA rodeos in Arizona that are different from the mandatory rodeos listed above.

- 11. It is the responsibility of MTC 2026 to provide and take care of her own clothing, transportation, horse, tack and equipment during any-and-all activities; and to arrange for a horse to ride at an event/rodeo if she is not hauling her own.
- 12. MTC 2026 agrees that the MTCP and Borderland Queen Enterprises, Inc. shall have the right to designate her female chaperone and traveling companion if and/or when one is needed for activities related to her participation in an event. When not chaperoned, she shall always conduct herself as a lady with no actions that might cause repercussions on the Turquoise Circuit, Borderland Queen Enterprises, Inc. or the Miss Turquoise Circuit Pageant.
- 13. It is expressly understood and agreed that in the event MTC 2026 does not perform under any part of this contract or gives up her title before the end of her reign, that the MTCP has the right to default, and she will forfeit the title of Miss Turquoise Circuit 2026. In that event, she shall immediately resign and forfeit the benefits hereunder. She shall return to the MTCP all awards and prizes to which she would otherwise be entitled, to include the saddle and buckle. In the event of her resignation, whether voluntary or upon request of Borderland Queen Enterprises, Inc. and the MTCP Board of Directors, the MTCP shall select her successor and such person shall be entitled to receive the prizes and awards as may be determined by the MTCP. Should a forfeiture be necessary, MTC 2026 shall immediately return the saddle, crown, chaps, vest, sashes, buckle, briefcase, flag and flagpole, and any other prizes that were awarded to her as Miss Turquoise Circuit 2026. Failure to do so shall result in legal repercussions. She may retain individual category prizes.
- 14. Miss Turquoise Circuit 2026 shall make regular contact with the President of the BQE, Inc., or their designated representative, to ensure that all is going well and as planned. This shall be in person, via telephone or text, Facebook Messages or email correspondence. She shall produce a list of planned appearances to said President well in advance of making the appearance. MTC 2026 and the BQE. Inc. will

have a shared calendar that will updated by the BQE Inc. Board and will include mandatory sponsor shout outs.

- 15. Miss Turquoise Circuit 2026 agrees that this Contract and the Rules of the Miss Turquoise Circuit Pageant shall regulate her rights and obligations as to her duties and responsibilities during her term as MTC, and that the MTCP/BQE Board decisions are absolute and final on whatever subject needs to be addressed. AND she agrees to hold harmless the Miss Turquoise Circuit Pageant, Borderland Queen Enterprises, Inc., and the Turquoise Circuit Board of Directors, for and from all liability that may arise from misconduct during her reign as MTC 2026. AND, that the intent hereof is that Miss Turquoise Circuit, above named, shall during the term hereof, render the services herein provided for exclusively to the MTCP, holding no other title until the end of her reign in October/November 2026.
- 16. MTC 2026 may have her vehicle and/or trailer wrapped at her own expense and it will need to be removed by January 1, 2027.
- 17. I willingly agree to participate in this program. I understand that **BORDERLAND QUEEN ENTERPRISES**, **INC.** and the **MISS TURQUOISE CIRCUIT PAGEANT** carries no accident insurance for this program and that the risk of injury from the activities involved in this program can be significant, including the potential for permanent paralysis and death. I knowingly and freely assume all such risks, both known and unknown. I do hereby, for myself, my heirs, executors and assigns, hereby release and hold harmless Borderland Queen Enterprises, Inc and the Miss Turquoise Circuit Pageant, their sponsors, the Turquoise Circuit Rodeo Board, their officials, officers, agents and/or employees, other participants, sponsoring agencies, advertisers, and if applicable, owners and leasers of premises and livestock used to conduct the event, with respect to any and all injury, disability, death, or loss or damage to person or property, whether arising from the negligence of the release's or otherwise, to the fullest extent permitted by law.
- 18. I understand that I am required to have medical insurance throughout my reign.
