E. PERSONNEL SUPPORT PROGRAMS POLICY MANUAL

1. CAF MESS MEMBERSHIP DIRECTION TRANSITIONED FROM CFAO 27-1 TO DAOD 5045-0, WHICH IN TURN REFERES TO THE PERSONNEL SUPPORT PROGRAM POLICY MANUAL. THIS CHANGE COMPLICATES UNDERSTANDING MESS MEMBERSHIP REQUIREMENTS FOR CAF MEMBERS
2. THIS DIRECTION CONFIRMS THAT ALL REGULAR FORCE AND PRIMARY RESERVE FORCE MEMBERS ARE REQUIRED TO BELONG TO A MESS APPROPRIATE TO THEIR RANK. MEMBERS OF THE SUPPLEMENTARY RESERVE, CADET ORGANIZATIONS ADMINISTRATION AND TRAINING SERVICE, AND THE CANADIAN RANGERS MAY APPLY FOR ASSOCIATE MEMBERSHIP TO A MESS
3. EFFORTS ARE NOW UNDERWAY TO REVIEW AND UPDATE POLICY INSTRUMENTS (REF B TO E) TO ENSURE ALIGNMENT AND CONSISTENCY IN THE APPLICATION OF THIS ORDER
4. AS THE SOURCE OF CAF DIRECTION, REF E WILL CONTINUE TO BE THE GOVERNING DOCUMENT FOR PROGRAMS ADMINISTERED UNDER THE NON-PUBLIC PROPERTY FRAMEWORK
5. MEMBERS ARE TO CONTACT THEIR LOCAL ORDERLY ROOMS WITH QUESTIONS RELATING TO THIS CANFORGEN
6. THE CMP ADMINISTRATIVE RESPONSE CENTRE (ARC) IS ALSO AVAILABLE TO PROVIDE SIMPLIFIED ACCESS TO CLARIFICATION AND INTERPRETATION OF CMP PERSONNEL POLICIES. THE ARC CAN BE CONTACTED AT:
