This is further to your *Access to Information Act* (Act) request received on September 13, 2024, for:

CMP DGMC Office of Interest: CMP and DGMC Request: 1. Any and all documents, emails, paper and digital products, from the CMP and DGMC that authorize the D MIL C to generate their own Unit Standing Orders; 2. Any and all documents, emails, paper and digital products, from the CMP and DGMC that authorize the D MIL C to generate their own Directives; 3. Any and all documents, emails, paper and digital products, from the CMP and DGMC that authorize the D MIL C to generate policy and governance that further restrict and/or assume authority that is not provided within CF MIL PERS INSTRUCTION 01-022 Remote Work; 4. Any and all documents, emails, paper and digital products, from the CMP and DGMC that authorized the D MIL C to generate and enforce their own local, unit standing orders and directives on remote work specifically the following guidance from the D MIL C being enforced by the Career Managers in regards to remote work that is not lawfully supported within the CF MIL PERS INSTRUC 01/22: "The D MIL C Remote Work Guidance: a. The gaining L1 must approve the request, not only the gaining CO; b. This cannot result in a cost move; c. L1 to perform a temporary EC to allow the Career Manager to post the member as a no cost move in Guardian; d. If the request is made due to personal circumstances, the compassionate status route should be taken first; e. Remote working should not be the default approach after a member has failed to find suitable accommodations at destination f. Do not assume remote work will be approved, plan as if it will be denied. Dates: 01-Apr-2022 to 13-Sep-2024


