**Request:**

**Methodology:**  
Information was taken from the Military Justice Tracking System where data from records of disciplinary proceedings from the CAF is kept. Reports were run to find cases at summary trial by rank, and filtered to include only cases where the accused member was a senior ranked officer.

Under the Summary Hearing system, members are no longer charges with service offences, rather service infractions therefore, no relevant records are found from 2022-2024.
