City of Harrison – Important Reminders

Local Option Tax (LOT) Payments

Local Option Tax payments are due on the 20th of the succeeding month. These funds help support vital City infrastructure, including streets, sidewalks, boardwalks, and parking improvements.

LID 1998 Assessment

LID 1998 payments are due January 31st. If you have an assessment due, you should have already received a notice.

Business & Liquor Licensing

Please ensure your business license and liquor license are current. All liquor licenses require City Council approval before they can be issued or renewed.

Parking Area Improvements

If you've noticed construction in the parking area across from City Hall, work is currently underway to create additional parking spaces.

The wood from the Springston Bridge will be repurposed and used in the parking area. Although the bridge is being removed, we will still have a piece of it preserved here in Harrison.
