## MEMO FROM THE MAYOR

I'm pleased to share that I recently met with Idaho Commerce to explore new grant opportunities for our city. So far, we've secured six grants.

As part of our ongoing efforts, we've made temporary sidewalk repairs to enhance safety—but these are only short-term solutions. This October, the City will apply for a sidewalk replacement grant, estimated at \$1 million. Ahead of that, we will be seeking public input and hosting a community workshop to gather your ideas and feedback. Please note: this upcoming grant is separate from the child pedestrian grant the city previously received.

### **Water & Sewer Project Update**

Progress continues on two major infrastructure upgrades: the Pend Oreille Water Line and the Central Force Main. Both projects are on track for completion by November 2025. We sincerely thank residents for their patience and cooperation during detours and construction activity.

### **Water Main Break**

During ongoing project work, a water main broke on September 25, temporarily disrupting water service to several homes. All affected residents were promptly notified. Contractors responded quickly and completed repairs in under two hours.

As a result of the break, some residents may experience temporary water discoloration. If so, please run your water until it clears.

### **Road Closures:**

Frederick Street between Lincoln and Pine, as well as Pine Street from Frederick to Lakefront, will be affected. Detour signs will be posted to help guide you through alternate routes.

### **Paving Notice:**

Starting October 20th, paving will take place on Park Avenue, Lincoln Street, and Pine Street. Please plan accordingly and watch for posted signage.

### **Audits**

We are currently finalizing the 2024 audit, which will bring us into full compliance. Since 2021, the city has successfully completed seven audits.

### **Comprehensive Plan**

The Comprehensive Plan is in its final phase of updates. The Planning and Zoning Commission is actively working to complete the remaining revisions.
