- **B.** Business/Liquor License Regulations **DISCUSSION**City Attorney Terrun Zolman explained that the city is authorized to regulate liquor licenses under Idaho Code Section 23-916 and business licenses under Idaho Code Section 50-307. However, the Idaho Code does not provide details on the extent cities are allowed to regulate liquor licenses or business licenses. Case law has provided little insight to the standard for a city's regulations as follows: "A city, in the exercise of its police power, can revoke a license if the particular thing permitted is or becomes a public nuisance, or such revocation is necessary and in the interests of the public welfare or public safety, and is not arbitrary, unreasonable, discriminatory, oppressive or capricious, and the conditions existing at the time justify such action."
