
The President's Corner:

August is National Immunization Month. It's also the beginning of back-to-school preparations and a good time to make sure your children are properly vaccinated before they head back to school. There is no one preventive health measure more important than immunization. As the World Health Organization notes, the international medical community has endorsed the use of vaccines and immunization to prevent and control a number of infectious diseases, as well as chronic diseases caused by "infectious agents." Vaccinating your child can avoid suffering and death associated with afflictions like diarrhea, measles, pneumonia, polio and whooping cough. The American Academy of Pediatrics says vaccines are 99% effective. Every vaccine goes through a series of tests before being approved to ensure safety. Vaccines are necessary to prevent the spread of infectious diseases. Some diseases that many had thought eradicated have reappeared, as polio did in Venezuela in 2018. Vaccines are studied intensively by the FDA, the CDC and many other organizations that vigilantly in keep watch over existing vaccines for possible complications. Herd immunity is when a certain percent of immunized people in a community reaches a level where everyone (including those who are too young or too sick to be immunized) get some degree of protection. It's important that as many people as possible get immunized. It's very risky to the health of other children to rely on herd immunity to protect your non-immunized child. By forgetting or opting to skip booster vaccinations, you are undercutting the effectiveness of herd immunity for both your own family and the community at large.

HOW TO OBSERVE

Check with your doctor about the vaccination needs for your family. Find out how to spread the word about the importance of vaccination and immunization in your community.

MOAA Seeks 12-Month Grace Period for New TRICARE Select Enrollment Fee

As the Defense Health Agency (DHA) works on implementation plans for the new TRICARE Select enrollment fee, MOAA is advocating for a 12-month grace period for impacted beneficiaries to ensure no retirees lose TRICARE coverage because they were unaware of the new enrollment fee requirement. “Military retirees have undeniably earned the TRICARE benefit via decades of service and sacrifice. The loss of health care coverage during a pandemic is an unreasonably harsh penalty for missing communications on an unprecedented enrollment fee,” Lt. Gen. Dana Atkins, USAF (Ret), MOAA President and CEO, asserted in a letter sent to DHA last week.

“A 12-month reinstatement period will minimize the number of military retirees who suffer this unintended consequence.”

Please note: The new TRICARE Select enrollment fee impacts only Group A retirees (those who entered service before Jan. 1, 2018.) It does not affect TRICARE for Life (TFL) or TRICARE Prime beneficiaries. It also does not apply to active duty family members, medically retired servicemembers and their families, and survivors on TRICARE Select. Starting Jan. 1, 2021, Group A retirees and their families must pay a monthly TRICARE Select enrollment fee to maintain TRICARE Select coverage. The charge for an individual plan is \$12.50 per month or \$150 annually. For a family plan, the enrollment fee is \$25 per month or \$300 annually. Later this summer, TRICARE will announce the process for setting up an allotment or making other arrangements to pay the fee. If you don't take action to pay the enrollment fee, you will be disenrolled from TRICARE Select on Jan. 1, 2021, for failure to pay. Current policy states you will have 90 days to request reinstatement.

Why a Grace Period?

MOAA believes it is important to extend the reinstatement period from three months to 12 for these four reasons: Past transitions suggest it is impossible to reach every beneficiary with updates about TRICARE benefits and requirements. Inevitably, some beneficiaries only learn about a new requirement when they try to use their benefit and find out they no longer have coverage. The COVID-19 pandemic has disrupted almost every facet of life, making it even more difficult to catch the attention of beneficiaries with critical enrollment fee information. TRICARE annual open enrollment messaging over the past two years has created a hurdle to effectively communicating the new enrollment fee by emphasizing beneficiaries who want to stay in their current plan don't have to take any action. This message is still being conveyed on the official TRICARE website. A 12-month grace period for the Select enrollment fee would be consistent with the 12-month grace period offered when the TRICARE annual enrollment requirement was established in 2018.

Why Isn't MOAA Fighting This Fee?

Congress passed this new Select enrollment fee as part of comprehensive MHS Reform legislation in the FY 2017 National Defense Authorization Act (NDAA), but it is just now being implemented. During the FY 2017 NDAA process, MOAA opposed and defeated several proposals for even higher beneficiary cost sharing, including enrollment fees up to \$900 and a proposed TRICARE for Life enrollment fee that would have charged Medicare-eligible retirees an annual enrollment fee equal to 2% of gross retirement pay (capped to \$632) for TFL participation. Because the TRICARE Select enrollment fee has been in law for several years and represents a compromise relative to higher fee increases proposed by Congress and the administration budget during the FY 2017 NDAA process, MOAA is focused on ensuring there is an effective communications plan and adequate grace period so beneficiaries do not lose coverage for the 2021 calendar year if they fail to pay the enrollment fee. 
Governor Kay Ivey issued her fifteenth supplemental emergency proclamation containing an amended Safer at Home Order that includes a statewide mask requirement. Individuals will be required to wear a mask or other facial covering when in public and in close contact with other people, as described in the order. This amended order extends until August 31, 2020 at 5:00 p.m.

Governor Kay Ivey on Friday awarded \$100 million of the Coronavirus Relief Fund to support two grant programs of up to \$50 million each for nursing homes and hospitals for the purpose of responding to and mitigating the COVID-19 public health emergency.

An Act of Congress established the United States Public Health Service Commissioned Corps and formalized the Commissioned Corps as the uniformed services component of the Marine Hospital Service. Congress organized Corps officers along military lines with titles and pay corresponding to Army and Navy grades.

The Public Health Service Commissioned Corps had its beginnings with the creation of the Marine Hospital Fund in 1798, which later was reorganized in 1871 as the Marine Hospital Service. The Marine Hospital Service was charged with the care and maintenance of merchant sailors, but as the country grew, so did the ever-expanding mission of the service. The Marine Hospital Service soon began taking on new expanding health roles that included such health initiatives that protected the commerce and health of America. One such role was quarantine.

The stated mission of the Commissioned Corps of the U.S. Public Health Service is "Protecting, promoting, and advancing the health and safety of the Nation" in accordance with the commissioned corps's four Core Values: Leadership, Excellence, Integrity, and Service. Officers execute the mission of the commissioned corps in the following ways:

- ◆ Help provide healthcare and related services to medically underserved populations: to **American Indians**, **Alaska Natives**, and to other population groups with special needs;
- ◆ Prevent and control disease, identify health hazards in the environment and help correct them, and promote healthy lifestyles for the nation's citizens;
- ◆ Improve the nation's mental health;
- ◆ Ensure that drugs and medical devices are safe and effective, food is safe and wholesome, cosmetics are harmless, and that electronic products do not expose users to dangerous amounts of radiation;
- ◆ Work with other nations and international agencies on global health problems and their solutions.

The commissioned corps uses the same commissioned officer rank structure as the United States Navy and Coast Guard: from ensign to admiral (O-1 through O-10). Commissioned Corps officers are typically appointed via direct commission, and receive the same pay and benefits as other members of the uniformed services. There are no enlisted members in USPHS. The commissioned corps is authorized to use warrant officer ranks W-1 to W-4 but does not currently use these ranks.



The Health Services Officer (HSO) category comprises over 50 allied health specialties, including audiology, social workers, physician assistants, optometrists, statisticians, computer scientists, dental hygienists, medical records administrators, medical technologists and others.

Ollie Edwards passed away on June 21, 2020. He leaves behind Virginia, his loving wife of 65 years. Please keep Virginia and family in your thoughts and prayers.



Colonel Ollie Herbert Edwards grew up in West Point, Mississippi and after graduating, he attended the University of Mississippi for two years in pharmacy school before becoming a cadet at Lackland AFB, San Antonio, TX. In 1954, he was commissioned as a lieutenant at Ellington AFB in Houston, Texas. His first assignment after being commissioned was at the then-under-construction Little Rock AFB, where he was the first lieutenant on base and served in multiple positions. As the new base expanded, he became a crew member of a B-47. During his 24 year military career his favorite assignment was being part of the Strategic Air Command at Columbus Air Force Base in Columbus, MS, and serving as a warfare officer on B-52s for six years. During this time he enjoyed a special camaraderie with crew members as they flew 24 hour chrome dome missions during the Cold War years with the Soviet Union. He delighted in telling the story of the midnight adventure of ejecting from an out-of-control B-52, along with all crew members except the pilots who were able to get control and land on base. He was stationed at Takhli AFB in Thailand during the Vietnam War where he was an electronic warfare officer on EB-66 airplanes. Upon returning from Thailand, after flying 123 combat missions, he was stationed at Wright Patterson AFB in Dayton, Ohio, and worked in various electronic warfare research and development divisions, ending his career with the prestigious assignment of Chief of the Avionics Research and Development Lab. During his military career, Edwards logged approximately 4300 flight hours and received numerous medals, including the Legion of Merit, a Distinguished Flying Cross, and seven Air Medals. Edwards retired on March 31, 1977. During his military service, Ollie received a Bachelor of Science degree in Math and a Master of Science in Mechanical Engineering, both from Auburn University. After retiring from the Air Force, the Edwards family returned to Auburn where Ollie flew for the University as an instructor pilot, and served as an assistant professor in the School of Aviation. He retired from AU in 1993. During his retirement years, Ollie obtained two degrees from Alabama Aviation College to become a certified airplane mechanic, and served as a consultant with the University Aviation Association and FAA helping American universities develop aviation programs. Col. Edwards was a man of deep faith, a member of Auburn United Methodist Church, and Harvesters. In honor of Col. Colonel William “Bill” Arthur Luther, Jr., passed away on Tuesday, July 7, 2020 while vacationing with his family in Panama City Beach, Florida. Colonel Luther was 83 years old and he was born on December 9, 1936 in Charleston, West Virginia. Bill was the only child of Colonel William Arthur Luther, Sr. and Pauline Tallichet Luther. Growing up in the Army, he was no stranger to patriotism and the sacrifices of a military family. He knew early on that his life's purpose was to serve his country, so Bill worked very hard as a young man to receive an appointment to the United States Military Academy at West Point, graduating with the class of 1959. The emotional bond to West Point, his Classmates and the ideals of Duty, Honor, Country were enduring constants that Bill held dear for all the days of his life. Over the course of a thirty-year military career, Bill served two tours in Viet Nam. He had assignments in Florida, North Carolina, Kansas, Washington D.C., and the Panama Canal Zone, where he commanded the 193rd Combat

Support Battalion, the largest unit of its type in the Army. He also received a Master's Degree in Political Science from Auburn University. His many military assignments in Intelligence, Infantry Units and the Department of the Army Staff uniquely qualified him as an expert in military science and research. His final assignment was at Auburn University, where he served as the Professor of Military Science until 1985. After his retirement from the Army, he remained at Auburn as the Director of Research Development. Proficient at many sports in his younger days, Bill especially loved to scuba dive the island waters of Panama. He was a true die-hard Auburn Football fan, who tried never to miss a home game unless it was to give up his seat for a friend. He could be found every October at the Hale Koa Barefoot Bar on Waikiki Beach, watching the sunset with a Mai Tai in his hand and a smile on his face. A pet lover, Bill was extensively involved with all aspects of the Lee County Alabama Humane Society. He was on the Board of Directors and also President for many years. A tireless advocate for animals, Bill saved the lives of many homeless, abandoned and abused dogs and cats. Bill is survived by his wife and soul mate, Carol; his son William A. Luther, III and wife Cheryl; and his daughter, Leslie Williams and husband Mark. He is also survived by five grandchildren; James Pearson, Paige and Brooke Luther, Casey and Luke Williams. Burial will be held at a later date at Arlington National Cemetery. A celebration memorial will be announced when circumstances permit. Alabama Absentee Voting During State of Emergency General Election 2020



(1) Pursuant to 17-11-3(e) of the *Code of Alabama*, and without limitation, due to the State of Emergency issued by the Governor of Alabama on March 13, 2020, as amended, any qualified voter who determines it is impossible or unreasonable to vote at their voting place for the General Election on November 3, 2020 due to the declared states of emergency, shall be eligible to check the box on the absentee ballot application which reads as follows:

"I have a physical illness or infirmity which prevents my attendance at the polls.

(2) Any qualified voter of this state who applies and successfully submits an application, with proper identification, for an absentee ballot pursuant to this Emergency Administrative Rule shall be eligible to vote an absentee ballot for the General Election on November 3, 2020.

(3) All Absentee Election Managers and any other election officials of this state are hereby directed and instructed to follow this Emergency Administrative Rule and accept all absentee ballot applications filed hereunder immediately.



Alabama Absentee Ballot Deadlines

- ◆ **In Person:** Received 5 days before Election Day.
- ◆ **By Mail:** Received 5 days before Election Day.
- ◆ **Voted ballots are due:** Postmarked 1 day before Election Day, received by noon on Election Day.

Alabama Absentee Ballot Directions

- ◆ Use our [Absentee Ballot Tool](#) to prepare your application.
- ◆ Sign and date the form. This is very important!
- ◆ Return your completed application to your [Local Election Office](#) as soon as possible. We'll provide the mailing address for you.
- ◆ All Local Election Offices will accept mailed or hand-delivered forms. If it's close to the deadline, call and see if your [Local Election Office](#) will let you fax or email the application.
- ◆ Double-check the deadlines and be sure to cast your voted ballot on time to be sure it is counted.
- ◆ Please contact your [Local Election Office](#) if you have any further questions about the exact process.

Tracking Your Ballot

- ◆ You can [track your ballot](#) directly with your state.

Once You Receive Your Ballot..

- 1) Once you receive the ballot, carefully read and follow the instructions.
- 2) Provide a copy of an acceptable form of photo ID with your voted ballot. (You must provide a copy of one of the forms of ID listed when you mail back your voted absentee ballot.)
- 3) Sign and date the affidavit where indicated.
- 4) A notary public or two witnesses must sign your absentee ballot envelope to verify your signature of the affidavit.
- 5) Mail your voted ballot back to the address indicated on the return envelope.
- 6) Double-check the deadlines and be sure to cast your voted ballot on time to be sure it is counted.
