## Legislative Chair—Charlie Block

## State & Local Legislative Issues & News

In previous newsletters I have laid out what is going on at the Federal level those things that are of interest to our readership. I wanted to expand that to the state level. Below are several bills that have been presented to the Alabama legislature. I believe it is important that we are aware of state issues as well as federal issues as some of the state items could directly affect us. The legislation covered by SB12 is something the MOAA state council of chapter's pursued as a standalone bill for several years. Combining the MOAA concerns with another bill should enhance its chance of passing.

**SB5:** This bill would grant a state income tax deduction for military pay and allowances to Alabama taxpayers not currently residing in the state, and who serve as active duty members.

**SB8:** This bill would expand survivor and education benefits to Alabama national guardsmen who are on state active duty for a period less than the existing 30-day minimum, so that guardsmen assisting with natural disasters or other emergencies may be eligible for state and federal benefits. This bill would also raise the compensation for surviving dependents of Alabama national guardsmen from \$10,000 to \$100,000.

**SB10:** This bill would extend tuition reimbursement for dually or concurrently enrolled high school/college students.

This bill would set the cap for private college tuition reimbursement at the rate of the public institution with the highest tuition and instructional fee rates. This bill would make clear that the Alabama National Guard Education Assistance Program will only pay for the first degree obtained and that short certificates, long certificates, and associate degrees are considered "stackable undergraduate credentials" which may be used to obtain a baccalaureate degree, thus the first degree obtained would be a baccalaureate degree. This bill would also clarify existing law so that institutions of higher education may clearly and consistently provide Alabama National Guard Service members with the ability to maximize their education benefits.

SB12: Under existing law, the Missing Senior Citizen Alert Act provides a rapid response to missing or lost senior citizens who are at risk of bodily harm or death. This bill would expand existing law to include missing and endangered persons suffering from a mental or physical disability who are at risk of bodily harm or death. (The MOAA state council is proposing to meld this bill with the Wisconsin SB 473 called the Green Alert. This will then cover service veterans.)

## New List of Agent Orange Test and Storage Sites Omits More Than 40 Previously Identified Locations — JANUARY 31, 2020

- The Department of Defense has released a new list of locations outside Vietnam where herbicides like Agent Orange were tested and stored, a compilation that could provide some veterans proof of exposure needed to support their VA disability claims.
- But the list, published Jan. 27 by the Department of Veterans Affairs, omits more than 40 locations previously noted as exposure sites by DoD in 2018 deletions that could undermine other veterans' pending claims.
- "DOD will continue to be responsive to the needs of our interagency partners in all matters related to taking care of both current and former service members. The updated list includes Agents Orange, Pink, Green, Purple, Blue and White and other chemicals," used to create the defoliants, Esper said in a release.
- MOAA Advocating for Improvements to Military Family Health Care at House Hearing FEBRUARY 04, 2020
  - MOAA will continue its work on behalf of military families Wednesday with testimony before a House Armed Services subcommittee hearing on DoD's Exceptional Family Member Program (EFMP), offering recommendations to improve both the program and the wider performance of the Military Health System (MHS).

## **NEWSLETTER SURVEY RESULTS**

We do not meet in June & July.



#### U.S. Coast Guard Cutters — Uncle Sam's Best Hockey Team

They came from Eveleth, Minneapolis, Sault Ste. Marie and New York City. They included a goalie called Mr. Zero, a menacing Italian - Jewish defense combination, the captain of the last New York Rangers Stanley Cup winners, a National Hockey League referee and a graduate of the Long Island City YMCA Roller Hockey League. A blend of amateur and professional players made up one of the finest hockey teams to represent Uncle Sam. They even had a pair of championships to prove it. They were the U.S. Coast Guard Cutters out of Curtis Bay, Maryland. The brainstorm of a former Michigan hockey player-turned sailor, the Cutters were organized shortly after the Japanese attacked Pearl Harbor. They played through the 1942-43 and 1943-44 seasons in the Eastern Amateur Hockey League, considered to be one of the most competitive leagues of its time.

### 6 Issues Trump Needs to Address During State of the Union Speech

When President Trump addresses the nation on Tuesday, February 4, 2020, he will have the opportunity to push several <u>issues of critical importance</u> to servicemembers, retirees, veterans, and military family members into the national spotlight.

#### Here are the six issues, and some of the work MOAA has done in each area.

1. Preserve Military Medical Care. Language in the most recent National Defense Authorization Act <u>slowed the Department of Defense's</u> <u>reduction of nearly 18,000 medical billets</u> pending a thorough analysis of the impact on readiness and beneficiaries. The president should stress a national commitment to ensure military beneficiaries have access to quality care, whether within DoD or through community care networks – especially important for families in need of care while in transition to new assignments or if their servicemember is deployed. RELATED: <u>Military Families Need a Safety Net During Military Health System Reform</u>

2. Protect TRICARE Pharmacy Coverage. MOAA continues to track changes to the TRICARE pharmacy system, some of which have resulted in <u>more medications dropping off the coverage list</u>. The president should make clear that benefits earned through service, including TRICARE, should not be traded away to pay for other programs, or to balance a budget.

3. Keep Military Pay Strong. In recent years, servicemember raises have matched private-sector wage growth – a feat that hasn't always been achieved, and one that's necessary to maintain the all-volunteer force. The president should underscore his commitment to this issue, and lawmakers must resist the urge to trim these raises to fund other budget shortfalls.

#### RELATED: MOAA's 2020 Legislative Mission

4. Don't Neglect Quality of Life Concerns. Fair paychecks for servicemembers are only part of the equation: From housing needs to shopping benefits to child care concerns, lawmakers must improve the services offered to military families if they want to keep the force strong. As MOAA continues to stress in its discussions on Capitol Hill, these programs aren't simply nice-to-haves as part of a military budget – decreased benefits and poorly delivered resources can lead to retention issues and harm overall readiness.

The president should convey this message to the American public, especially to civilians who may not be familiar with the importance of these programs.

5. Do It All on Time. Continuing resolutions and shutdowns have cost DoD billions, while servicemembers and federal workers continue operations without pay. As MOAA fights for the programs outlined above, lawmakers can help by moving the appropriations process forward in a timely fashion. The current system of long delays, longer extensions, and brinksmanship as the finish line nears makes implementing DoD and VA essential programs nearly impossible, creating uncertainty from the highest planning levels to those awaiting word on key benefits programs ... or even whether they'll receive their paychecks.

The president should stress that such delays are unacceptable and commit to working with Congress to move more efficiently.

6. Commit to Treating Traumatic Brain Injuries. The administration should renew and reinvigorate research and treatment of traumatic

VA and Walgreens are national partners, providing no-cost standard (Quadrivalent) flu shots to enrolled Veterans of the VA health care system. Simply go to any Walgreens, tell the pharmacist you receive care at a VA facility and show your Veterans Health Identification Card and another form of photo ID.

With the VA-Walgreens partnership, after a Walgreens pharmacist administers a vaccine, the immunization information is transmitted to VA through the eHealth Exchange and becomes part of the patient's VA health record. The no-cost flu shot program starts August 15, 2019 and runs through March 31, 2020.
