Wreaths Across America

Turning the Tide on Veteran Suicide®

Headlines nationwide are sounding alarms—Suicide is Increasing. The CDC recently reported that suicidal thought has doubled in 2020. Sadly, the Veteran community holds a disproportional number of the nearly 50,000 losses that occur annually.

Our November meeting will address the subject of suicide and the steps that we can take to build a culture of mental health among veterans and all at risk within our community. Guest Speaker, Chaplain (LTC) Lou Koon will share insights from his work in intervention, that includes more than 1,400 successful suicide interventions since 2012. Of particular note, is the danger of being so focused on looking for signs that we miss 20% that are at risk without signs. They too can be helped.

While the typical epidemic calls for white coats in research labs and hospitals, the epidemic of suicide is best stopped by ground forces of ordinary people willing to engage in meaningful discussion before the coats show up. You don't have to be the First Responder on the bridge desperately trying to talk a person down. You can be the real first responder who is able to help those at risk before they ever get to the proverbial bridge of despair.

“Happy 245th Birthday”



November 10 , 1775

The USMC birthday was officially recognized in 1921. Major Edwin North McClellan of the Marine Corps History Division submitted a proposition to the ranking commandant which advocated for the anniversary to instead be designated on November 10.

On November 10, 1775, just eight months shy of the Declaration of Independence, a new corps was formed following the introduction of the Continental Marine Act.

At the time, an official plan was developed by the Continental Congress to oversee a mission intercepting ammunition cargo from Britain, using Marines. This resolution made in November to create a stand-in official Marine Corps force, was essential to the formation and modernization of the now U.S Marine Corps. Having taken part in nearly every U.S. conflict, the Marine Corps has defended our country since America’s inception. The Corps, with over 186,000 active duty members and 38,500 reserves as of 2017, continues its proud tradition as protectors of the U.S. and its people.

Legislative Chair—Charlie Block

National, State, & Local News

At a recent Legislative Forum I attended Dana Atkins CEO of MOAA spoke. Two of the things he pointed out as current issues are proposed changes to the Military Healthcare system. What many of us don’t know is that the TRICARE reimbursement rate is less than the MEDICARE rate and as a result folks in certain areas will have difficulty getting a doctor to serve them if they can no longer use a Military Treatment Facility.

The second thing Atkins talked about was Arlington Cemetery. I have copied current information from MOAA about this issue: The public comment period opened Sept. 15 and will close Nov. 16. MOAA will continue to encourage our members and others to comment. Arguments Against the Changes

- ◆ The proposal will force those who have already made end-of-life plans to make difficult decisions – in some cases, the family will have to decide on behalf of the deceased with no previous input or planned options.
- ◆ The changes, which would force more people to a different cemetery, do not account for all-important military honors.
- ◆ The proposed eligibility, emphasizing combat and the Purple Heart, diminishes the value of career-long service for others who wore the uniform, particularly those who shared similar risks

Legislative Chair—Charlie Block (Con't)

- ◆ The proposed eligibility, emphasizing combat and the Purple Heart, diminishes the value of career-long service for others who wore the uniform, particularly those who shared similar risks in the air and at sea.
- ◆ As proposed, the changes could end up being discriminatory against some military branches and specialties, and against those whose gender prevented them from serving in certain capacities. MOAA has requested, and has been unable to obtain, any reliable information from DoD or the Army on how the proposed changes impact eligibility from each service or how the changes impact eligibility by gender. We can only conclude such information was not considered in any meaningful way when the proposal was developed. Without this information, it is fundamentally unfair and disrespectful to the entire veteran community to rush through these new exclusions on Arlington eligibility.
- ◆ The proposal allows for eligibility of political appointees, possibly displacing a more deserving service member. It's an unpopular change among many MOAA members; any changes that narrow eligibility for those who served a career should not be used to create space for political appointees not otherwise eligible.

MOAA's Recommendations

- ◆ Grandfather those who are currently eligible to account for 20-year retirees who have already intended ANC to be their final resting place.
- ◆ Expand ANC using non-contiguous federal land, which would allow years to figure out how to bestow similar honors at partnered or sanctioned locations. MOAA is concerned non-contiguous expansion was not considered with the same fervor applied to eligibility.
- ◆ Change the time horizon to 90 years. The planning criteria for extending the life of ANC for 150 years was arbitrary and spans over the next five generations. Conditions for the past five generations are not a reasonable yardstick when looking five generations forward.
- ◆ Extend the period of implementation. A protracted period of three to four years would afford time to create a reservation system to gauge intent for those currently eligible and examine the creation of ANC annexes through noncontiguous expansion, as specified in Public Law 114-158 and outlined above. Congressional approval and oversight for the final determination is needed to ensure the intent of this law is met.

What Is Next?

When the Federal Register public comment closes, it will take over a year to reconcile and resolve legal challenges before approval. Existing ANC standards will remain in effect during that time. Intervention from elected officials may be required to change course for reduced eligibility for our national cemetery.



Suicide is not the result of wanting to die. It is the result of loss that leads to hopelessness and that hopelessness is so overwhelming that it short-circuits the coping mechanisms to the point that suicide seems to be the only option. Caring and courageous individuals willing to listen, learn, and lead offer incredible power to reignite hope when it seemed all hope was gone.



About Lou

Dr. Kenneth ‘Lou’ Koon is an author, speaker, interventionist and Chaplain (LTC) in the USAR. He is the founder of Armed Forces Mission and the Intervene Challenge. In 2012 he developed the Listen Learn Lead model of suicide intervention after his own brush with suicidal thoughts. More than 17,000 individuals have participated in L3 training including members of the 101st Airborne, the 169th Fighter Wing US Air National Guard, Homeland Security, Universities, and hundreds of law enforcement agencies throughout the US. Lou was honored as the Trinity Awards Emergency Responder of the Year and inducted into the University of North Georgia Alumni Hall of Fame in 2018 for his work in intervention. He a member of the Georgia Chiefs of Police Association, National Alliance on Mental Illness, and International Critical Incident Stress Foundation. Lou holds a Master of Divinity in Education, Doctorate in Counseling, and completed his clinical education at Piedmont Hospital. He and his wife, Sherry are the parents of four grown sons. Two are Air Force, one was Coast Guard, the youngest is a Fireman/EMT with the Atlanta Fire Department. They have four grandchildren and one on the way and love spending time with the family at Lake Wedowee Alabama.

UNITED STATES MARINE CORPS RECON

Force Reconnaissance (FORECON) is one of the United States Marine Corps' special operations capable forces (SOC), and supplies essential elements of military intelligence to the command element of the Marine Air-Ground Task Force (MAGTF), by supporting their task force commanders, and their subordinate operating units of the Fleet Marine Force (FMF). Historically, the Force Recon companies, detachments and platoons performed both deep reconnaissance and direct action (DA) operations. Some missions are now shared by the Marine Special Operations Teams (MSOT), due to the establishment of the U.S. Marine Special Operations Command (MARSOC) in 2006.

These important issues require your **immediate attention**. Send your elected officials a MOAA-suggested message today. ***Press the control key and then click on the link.***

Urge Your Elected Officials to Support Legislation to Stop Cuts to Military Medicine Act now to urge your senators to support FY21 NDAA legislation that will halt MTF restructuring as well as cuts to uniformed medical personnel billets. While the House NDAA draft includes critical provisions, the Senate version remains silent. Ask your senators to support these protections and push for their inclusion in the final NDAA.

Ask Your Lawmaker to Help Expand Benefits for Tens of Thousands of Vietnam Veterans The Senate version of the FY 2021 National Defense Authorization Act (NDAA) would expand VA benefits available to Vietnam veterans exposed to herbicides such as Agent Orange, adding conditions scientifically linked to such exposure.

Protect Gold Star spouses during future shutdowns Under current law, Gold Star spouses receiving benefits from the Department of Defense are protected from interruptions in payments during a government shutdown. But because Coast Guard paychecks come from the Department of Homeland Security, these survivors are still at risk.

Urge your legislators to support concurrent receipt Contact your representative and senators and urge them to support H.R. 5995, the Maj. Richard Star Act, and the companion S. 3393 -- which would provide concurrent receipt for servicemembers unable to complete 20 years of service due to their combat-related injuries. Help ensure these men and women get their full service-earned retirement, as well as their disability compensation from the VA.

Act now to extend CHAMPVA coverage Did you know many adult children of veterans who are disabled or who died from a service-connected disability risk losing their health care through no fault of their own during the COVID-19 pandemic?

Support the Jobs and Childcare for Military Families Act

According to Department of Defense data, 24% of the military spouse labor force remains unemployed. That's over six times higher than the national unemployment rate. Additionally, many military families feel the impact of the rising cost of health and dependent care. To retain the best and brightest in an all-volunteer force, we must remove as many barriers to family financial stability as possible. Ask Congress to expand the Work Opportunity Tax Credit to military spouses and provide Flexible Spending Accounts as a servicemember benefit.
