Presentation: European Military Cemeteries from WW1

Guest Speaker: Bob Cochran

At the end of the First World War there were many hundreds of military burial grounds. They range in size from large cemeteries located in or near a village or town which had been behind the old Front Lines to small groups of battle-field burial and individual plots. These battlefields and cemeteries contain the resting place of many thousands of soldiers of different nationalities who died during WWI.



Bob Cochran graduated Auburn University in 1974 and was commissioned into the Navy through the ROTC program.

Bob served in the U.S. Navy for 20 years retiring as a Commander, Navy pilot flying P-3s. He served on the USS John F. Kennedy. He was stationed in Jacksonville, FL; Corpus Christi, TX; Norfolk, VA; Maxwell AFB, AL; Carlisle, PA; Wales, UK; and deployed to the Indian Ocean, North Atlantic, Mediterranean Sea, Sicily, Iceland, and Bermuda. Bob also visited 63 different countries during his Navy career.

He graduated Law School in 1997, practiced law in Auburn, taught Business Law at Auburn University part-time from 2005-2008, and began full-time teaching in 2008. He is married to Karen, and they have three grown children– Christy, Kelly, and Clint.

- The meeting was adjourned at 6:10 p.m.



Take Action Now on Critical Issues Facing the Uniformed Services and Veteran Communities

In this pivotal year for our nation's servicemembers and veterans, MOAA remains at the forefront in the fight for key legislative changes. Our spring campaign event, Advocacy in Action, saw hundreds of supporters from across the nation gathering on Capitol Hill to spotlight critical issues affecting the uniformed services and veteran communities.

MOAA is grateful to you and others who have engaged in our advocacy efforts through MOAA's Legislative Action Center. To sustain this momentum, we are urging you and our more than 360,000 members to engage with elected officials during the congressional summer recess. Legislators will be in their home states for the next month, providing a unique opportunity for personal outreach.

Key MOAA advocacy priorities:

- Junior Enlisted Pay Raise: Competitive pay remains critical to the health of the allvolunteer force, and both the House and the Senate seek to address this issue in the National Defense Authorization Act (NDAA). The House NDAA calls for servicemembers E-1 to E-4 to receive a 15% pay raise beyond the 4.5% earmarked for all in uniform. While the Senate version calls for an additional 1% increase for servicemembers E-1 to E-3 (beyond the 4.5% raise).
- Basic Allowance for Housing (BAH) Restoration: Access to quality housing and promoting financial wellness are important to sustaining the all-volunteer force. Restoring BAH addresses both issues. The House version of the NDAA would restore BAH to 100% for FY 2025 – a move toward MOAA's goal of full repeal of the BAH reduction, but not a permanent fix. Unfortunately, the Senate version does not address the issue.
- **Major Richard Star Act:** Tens of thousands of combat-injured veterans lose a dollar of earned DoD retirement pay for every dollar of VA disability compensation. For three years in a row, over two-thirds of Congress has supported the Star Act, which would end that unjust financial offset. Despite this vast support, neither version of the NDAA includes the bill. However, it is critical lawmakers continue to hear about this important issue, especially as we approach the start of the 119th Congress.
