By signing and dating this contract, you agree to the terms set forth by Orland Park Comic Con (OPCC) and the Orland Park Sportsplex. The cost of your booth(s) is \$200 each if paid for by February 1st 2019. Included with each 10x10 booth is (1) table cloth, piping and draping, includes (1) 8 foot table, 2 chairs and 2 Dealer Passes.

Extra tables, chairs and passes are available, prices are listed below. Any and all additional furnishings must be ordered when you request your booth:

Extra Chairs - \$5

Extra Dealer Passes - \$20

Payment methods:

- Payments must be made in full by February 1st 2019 to secure your booth. Any booths not paid in full will be made available to other interested dealers and any deposits will be forfeited.

DEALER CONTRACT (Guests, Exhibitors, Artists and Vendors) – April 26th – 28th

****Load in and Load out: ****

- Load in and setup times for the show are from 9:00 a.m. to 5:00 p.m Friday April 26th and 7 a.m – 9 a.m. Saturday April 27th.
If you are not able to setup during these times, please notify OPCC management as soon as possible because you will not be able to setup during operating hours.
- Breakdown and load out times for the show are from 5 p.m. – 8 p.m. on Sunday April 28th.

1. Booth space

- OPCC will provide your booth space (10'x10') pipe and draped, one 8' table and two chairs. Additional tables and chairs can be rented.
- OPCC provides the above equipment with each booth. You may provide your own tables, chairs and displays. All additional equipment and furnishings are the sole responsibility of the Dealer.
- Electrical power is available in limited areas; it will need to be requested in advance and will be available on a first come first serve basis.
- Wi-Fi will be free throughout OPCC.
- Dealers will keep booth areas clean and are responsible for damage that may be caused to the venue, booth furnishings or other dealers' property. Dealers agrees to leave their area clean and debris free at the close of the show.
- OPCC reserves the right to change booth locations at the promoter's discretion.

2. DISPLAY REGULATIONS

- A. No exhibit may block or interfere with any neighboring exhibit or aisles.
- B. Banners are allowed, but nothing may be hung on the walls or affixed in any manner to the ORLAND PARK SPORTSPLEX.
- C. OPCC will supply table cloths for all tables provided with the booth . Dealers may supply their own only if they so choose..
- D. Music and other sound systems must be kept at normal volume level. If the volume of any device is too loud the dealer will be asked to turn down the volume or to shut off the device.
- E. Any damage caused to the building and its contents, accidental or otherwise, is the sole responsibility of the dealer.
- F. You may go outside to smoke, but you must adhere to the posted signage on the property as to the allowed locations. No smoking or vaping is allowed inside the ORLAND PARK SPORTSPLEX.
- G. Creators may begin breakdown early with permission of OPCC

3. PAYMENT FOR SPACE

- A. Dealer understands the payment policy stated above and agrees to pay all fees stated in writing on this contract.
- B. Refunds for booth spaces must be requested by MARCH 15th 2019 to be considered, but there are no guarantees that a refund will be granted. After March 15th 2019, there will be no refunds considered.
- C. Refunds will not be available due to Force Majeure (see below).
- D. Subletting space is not allowed.
- E. Sharing of booth space is allowed, but only with express written consent of OPCC. In cases of more than one Dealer sharing a booth; the person whose name appears on this contract assumes full responsibility for that booth, as specified in this contract.

4. MERCHANDISE FOR SALE

- A. Comic books, prints, artwork, toys, video games, trading cards, etc; standard pop culture fare Only original DVD's are allowed to be sold, NO COPIES, NO BOOTLEGS ALLOWED.
- B. Creators are responsible for the legality of the items they sell. NO KNOCKOFFS.
- C. ADULT MATERIAL
 - Dealer agrees not to sell or distribute any adult material to minors.
 - All adult material must be bagged or covered in a way that minors may not open or see it (bagging, covering with tape). Any nudity must be covered (bagged, covered with tape).
 - Adult magazines ARE NOT allowed to be openly displayed. They must be kept behind tables at the booth. A sign may be posted to let customers know that you carry this merchandise.

5. SECURITY

- A. OPCC and The ORLAND PARK SPORTSPLEX are not responsible for any theft or loss.
- B. Dealer is responsible for their own security during the show hours.

6. LIABILITY AND FORCE MAJEURE

- A. The Dealer agrees to protect, keep, and save OPCC the promoter of this event, forever harmless from any damage(s) or charge(s) imposed for violations of any ordinance or regulation by the Dealer, his employees or agents, as well as failure to comply with the terms and agreements of this contract. Further, Dealers shall at all times protect, indemnify, save, and keep OPCC against any from any loss, cost, damage, liability, or expense which arises out of or from or by reason of any act or omission of the Dealer, his employees, or agents.

B. In the event the ORLAND PARK SPORTPLEX or any part of the convention are thereof is unavailable, whether for the entire event or a portion of the event, as a result of fire, flood, tempest, or another such cause, or as a result of a governmental intervention, malicious damage, acts of wars, strike, labor disputes, riot, or agency which OPCC has no control, or should OPCC decide that because of any such cause it is necessary to cancel, or postpone, or re-site the event, or reduce installation time, exhibit time, or move out time, OPCC shall not be liable to indemnify or reimburse the Dealer in respect of any damage or loss, direct or indirect, arising as a result thereof.

7. AMENDMENTS:

OPCC shall have the full power in the interpretation and enforcement of all contract regulations contained herein, and the power to make such amendments thereto, and such further rules and regulations as shall be considered necessary and proper.
